THE DAMAGE TO Q3 (MY CAR) WAS THAT THE FRONT RIGHT BUMPER WAS SLIGHTLY COMING OUT OF ITS ALIGNMENT, THERE IS SCRATCH SLIGHTLY TO THE FRONT RADIATOR GRILL (MINOR) BUMPER CAP WHICH WAS SLIGHTLY DISLODGED ON THE RIGHT SIDE WAS FIXED BY PUSHING IN.
