Brief Details.

On 01/01/2024 at around 1525hrs, I was driving my vehicle, JRT9597 along Woodlands Avenue 9. The traffic light arrow was green and was in my favor. I make a turn to Woodlands Street 81 when a red car SMG6201G was going straight from the opposite side did not stop and hit our vehicle.

As there were many cars, I drove a bit forward so as not to block the road. I did not manage to come out of the car as I felt giddy. A few minutes later, I realized that my passengers and I was injured. I came out of the car after I was well and went to make a check on the driver for the red car. I called the police.

Traffic Police came to scene and interviewed me. A few minutes later, ambulance came and make a check on all of us.

My car damaged at my 2 left side doors was badly dent and was not able to open. As the interior, my dashboard board, my aircon and the radio came out and slant. I sustained abrasion on my left thigh and upper thigh. As for my passengers, one of them sustained chest pain and cut at my left arm. The other passenger sustained some scratches on her left legs, pain at the shoulder area and left elbow pain. Paramedic checked on us and does not require us to be conveyed.

As for the red car, the damaged was the front bumper came off and the plate number dropped. But the driver does not have any injuries on him.

We exchange particulars, and the traffic police officer asked me to lodge accident report at any police station. I wished to state that I did not have any in car camera installed in the vehicle.
