Describe Circumstances of the Accident

As of above date & time, I was driving my vehicle (SMQ9229E) along PIE towards Tuas on the right lane of a 3 lane expressway. On Jln Tunas Flyover, vehicle C (SLX1531J) which was in front of my vehicle suddenly braked. I followed accordingly. Out of a sudden, vehicle B (SMG7816B) collided into the rear portion of my vehicle. Due to the impact, my vehicle surged forward & collided into the rear portion of vehicle C. I alighted & discovered I was involved in a 5 car chain collision involving vehicle D (SLU589R) & vehicle E (SKQ 583P).

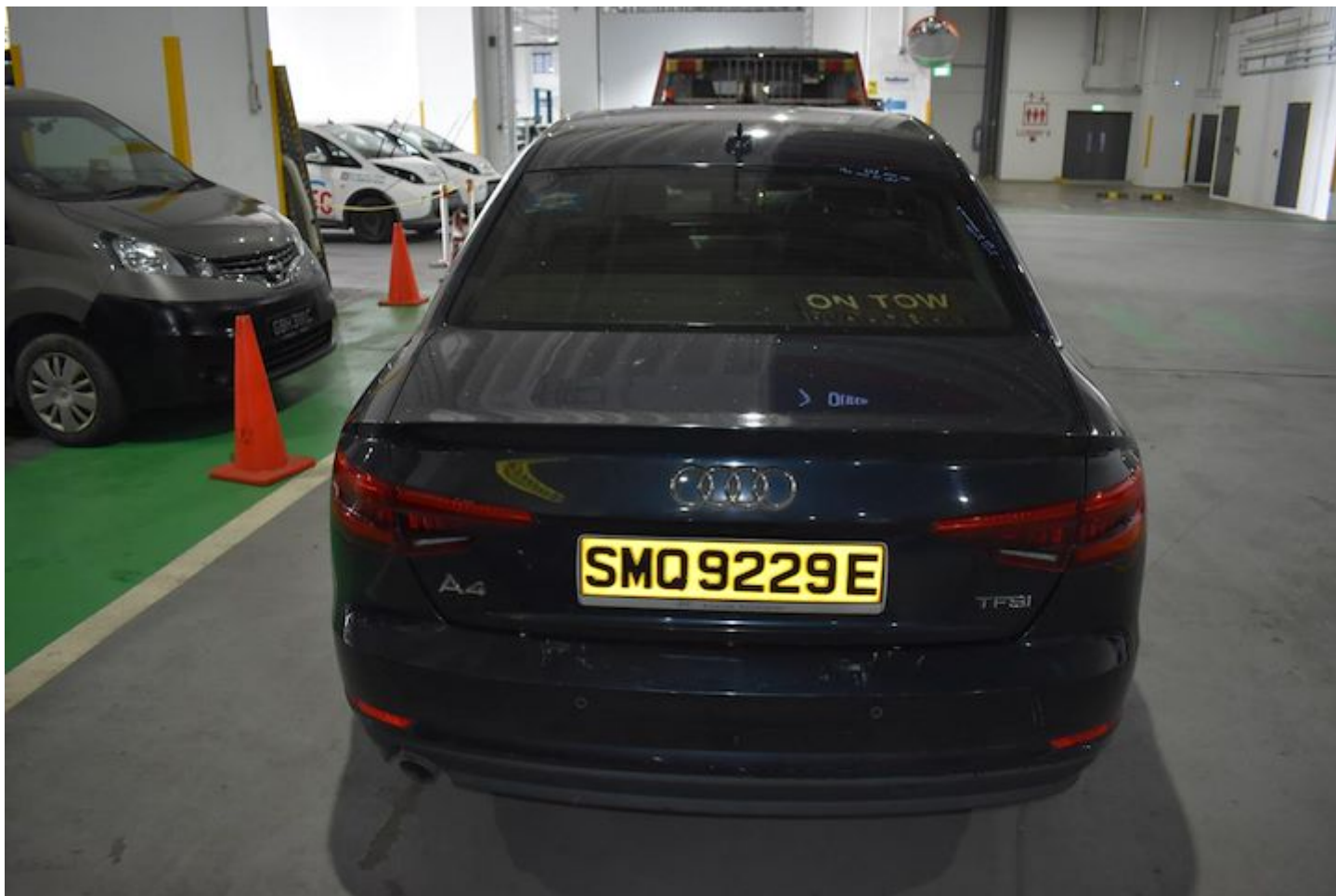
