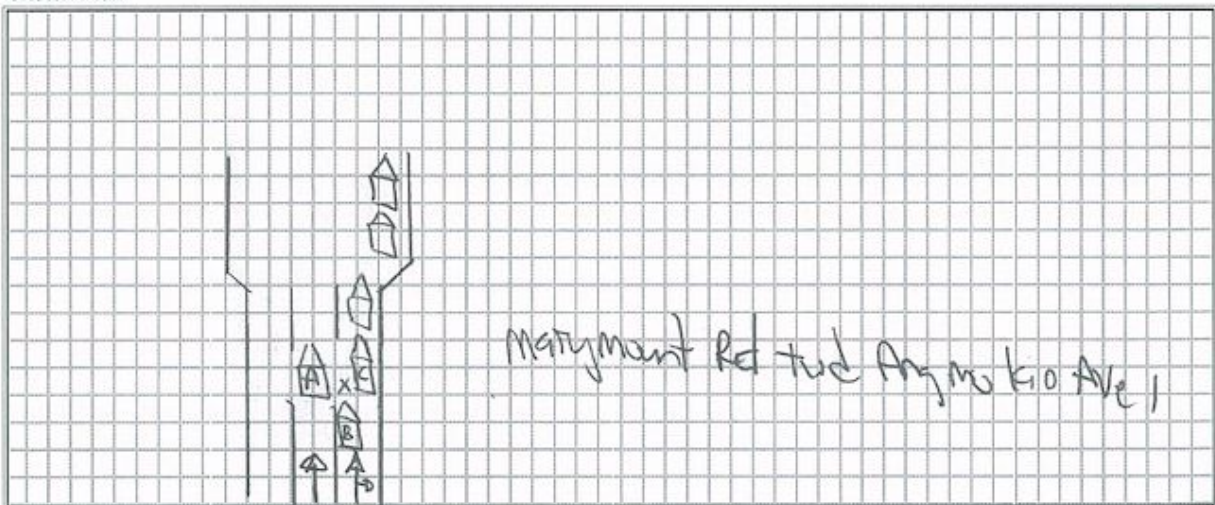

**Describe Circumstance of the Accident**

DATE OF ACCIDENT: 15/08/2024 TIME OF ACCIDENT: 6.40-6.45pm  
VEH A: SKW1497S VEH B: FBL6595Z VEH C: SML5812Z

I was driving off from Depot road heading Lornie road around 6:40pm. The day was dizzying and the traffic were slowed and congested from Lornie toward MaryMount. Around 6.40-6.45pm traffic remain heavy and I was maintaining 30-45km/h. along MaryMount Rd toward Ang Mo Kio MRT direction.) While looking from my car rear mirror, I saw a red motor cycle cutting from behind left Lane 3 toward Lane 1. The Car on right SML5812Z was slowing down when the traffic heading Ang Mo Kio Ave 1 stop. This motorcycle: FBL6595Z speed up trying to squeeze the gap of both car. And he hit the right car SML5812Z and damage my rear right bottom skirt. My car suffered the right side skirt drop due to restless behaviour of motorcycle: FBL6595Z rushing for his delivery (foods).
