LETTER OF AUTHORISATION

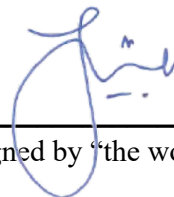

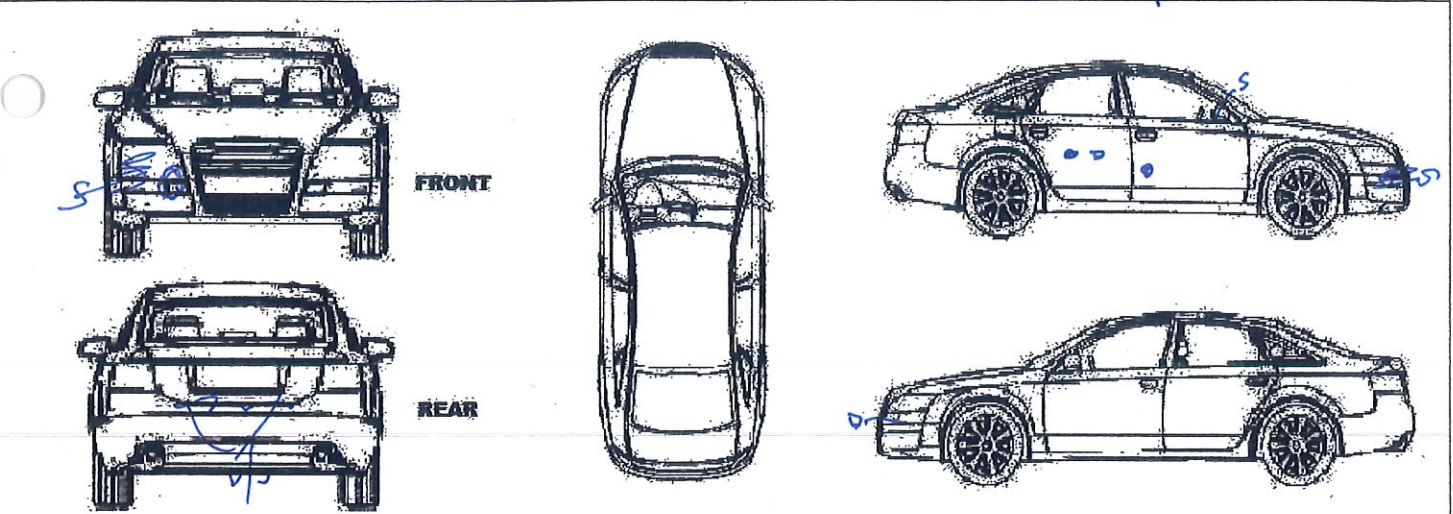
