Brief Details.

Accident happened along PIE towards Changi, before Exit 16 (Toa Payoh). I was riding along lane 1 and Taxi (SHA5170J, Jason Goh Hock Beng) made an abrupt lane change to cut in front of me. I was forced to e-brake to avoid a collision and skidded on the road. SHA5170J caused the accident and continued to drive off. Another rider, Mr Ang, went to chase and stop the taxi, then called the police. All 3 parties had given a statement to the Traffic Police on the scene. I was then convened to Tan Tock Seng Hospital.

I do not have footage of the accident, but Mr Ang that is willing to serve as a witness for this accident (Mr Ang, +65 9223 2243).
