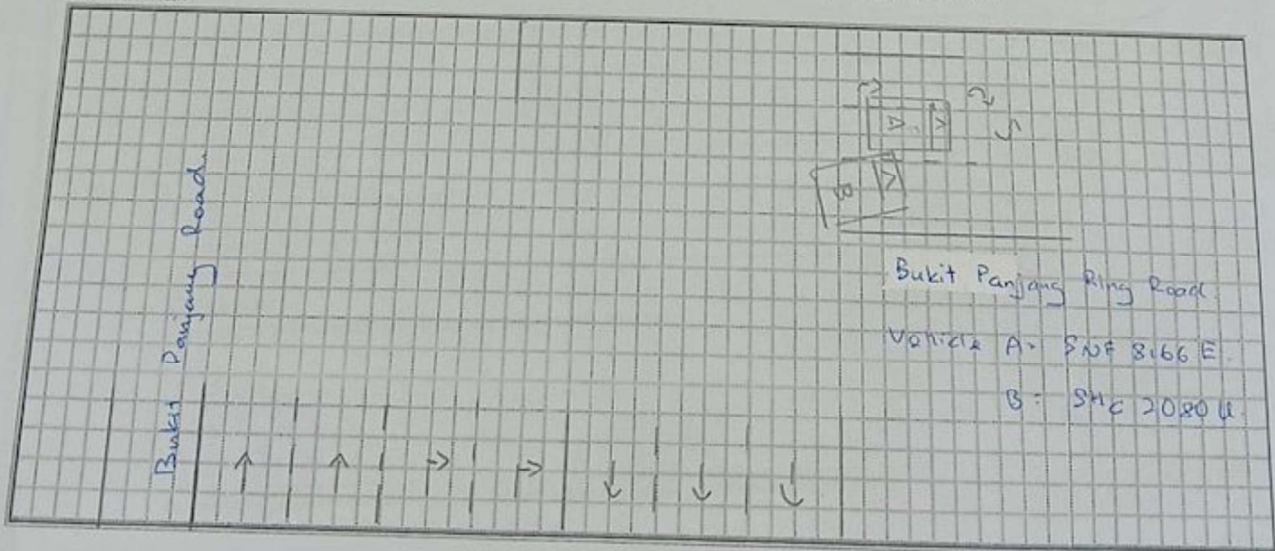
SKETCH PLAN
