

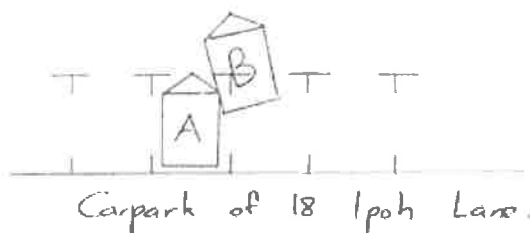

B = SNB 7281H


Describe Circumstances of the Accident
