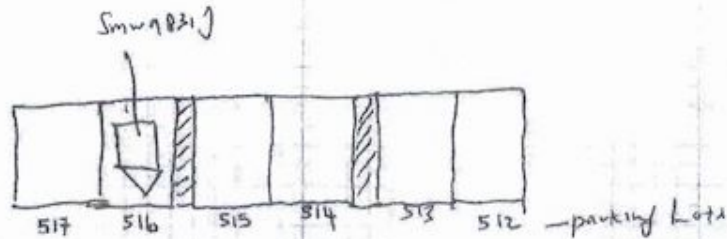

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I parked my car in my condominium basement parking lot number 516 on 28/6/2024 and did not drive it over the weekend. When I returned to my car on 1/7/2024, I discovered it was covered with soil & leaves. Inside the car, the floor area of the front & rear passenger seats was flooded with water and the electronics of the front passenger seat no longer work.

Above the area where I parked, there is a vent opening in the ceiling. It was covered with leaves & soil. There are also soil stains on the wall and leftover soil debris on the floor.

You had been advised by workshop that in the event that you wish to claim against your own policy (OD claim), there is a **Fourteen (14) days clause** whereby the claim must be made within the stipulated timeframe from the day of occurrence.
