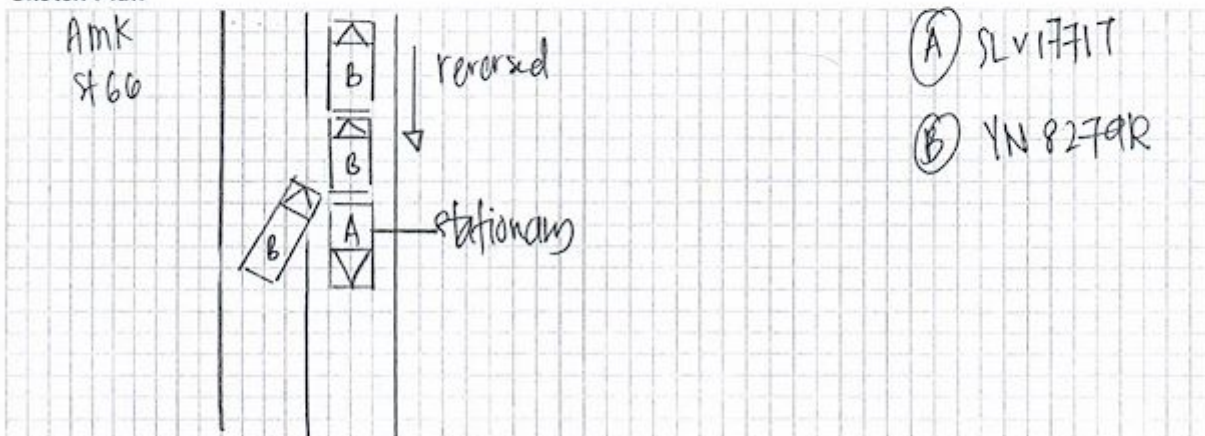

## Describe Circumstances of the Accident


On 22.08.2024 at about 1930hrs I parked my vehicle along
