We have a new matter which we would like to appoint LKK to assist in conducting a physical inspection and providing a survey report of a damaged SIA vehicle (regn: RU5937R).

Briefly, a SATS tractor was towing 3 containers when one of the containers was not properly secured. While towing past the roadway in front of C17, the first container collided into a stationary vehicle (regn: RU5937R) belonging to SIA on 19 August 2024. As a result, this has caused damage to the SIA vehicle. We attach herewith videos of the incident and photos of the damaged vehicle to provide a better understanding of the damage to the vehicle.

We understand that SIA have been in contact with SATS requesting for a settlement. However, we have not yet been provided with a copy of the repair estimates. In the circumstances, we shall be grateful if you could urgently let us know (a) if LKK would be able to take on the appointment, and (b) confirm that your fees for a physical inspection is SGD 650 (before GST).

We understand that the damaged vehicle is currently located at C17 within the airside. As there may be some form of security clearance to access the airside for the survey, please kindly contact SATS BU to arrange for the inspection:
