














Figure B-5: Front view of SLU 5390M

**PART I: STATEMENT OF SERVICEMAN**

While on Sembawang Road my vehicle MID22024 side swiped a civilian vehicle on the left. The vehicle MID22024 was on the second lane proceeding straight when the left side of the vehicle grazed a civilian vehicle, the weather was dry and visibility was good. Traffic was heavy and I failed to judge properly thinking that there was enough space. After the incident we stopped on Mandai Ave and the vehicle commander went down to talk to the civilian.

**PART I: STATEMENT OF SERVICEMAN**

On 26<sup>th</sup> August, I, 1SG (NS) LIM KAH YE, alongside with 3SG (NS) ABRAM and CPL (NS) BRANDON WONG (TO) was moving out to Gedong from Khatib Camp [REDACTED]. At around 0656hrs, we were moving on Sembawang Road looking to turn into Mandai Avenue. There was heavy traffic on all lanes and some works on the road. We were on the outermost lane for turning right a few cars from the junction. When the right green arrow showed up, we advanced to the junction and passed a few vehicles before hearing a scrape on our vehicle while we were still moving straight. We proceeded to activate warning light stopping at Mandai Avenue where a white civilian car came to us. There were scrapes to the right surface of the car and he was actually on the lane left of us heading straight.

Driver was alert and I was looking out for hazards as well. Before the contact, I have sounded out to 3SG Abram and CPL Brandon on a motorcyclist that has slotted himself between our vehicle and another tonner in front of us. We have reduced speed and hence was lagging behind the tonner ahead by a few vehicles.



**PART I: STATEMENT OF SERVICEMAN**

Our 6 tonner was moving out from Khatib Camp to Sungai Gedong Camp for FTX. In the main cabin, seated left to right, 1SG (NS) Kah Ye, 3SG (NS) Abram, CPL (NS) Brandon.

We left Khatib around 0650hrs. The incident happened as we were moving along Sembawang Road, preparing to turn right onto Mandai Avenue. Due to peak hour, traffic was heavy and slow moving. The civilian vehicle in question was in the lane to our left, which would proceed straight on Sembawang Road. We were in the left most lane to turn right onto Mandai Avenue. As we followed the flow of traffic in our lane, moving straight we heard a bump and realised we may have grazed a vehicle in the next lane to our left. As traffic was heavy, we made the right turn at the junction and stopped along Mandai Avenue to wait for the civilian vehicle.

The incident happened around 0656hrs and we made contact with the driver around 0709hrs. We had managed to pass other vehicles before in the same lane as this vehicle. To add, VC and driver was alert to road condition. Before the incident, 1SG (NS) Kah Ye had remarked regarding a motorcyclist which had slotted himself between our vehicle of the one in front. I believe this shows how they were alert to the traffic conditions at the time.
