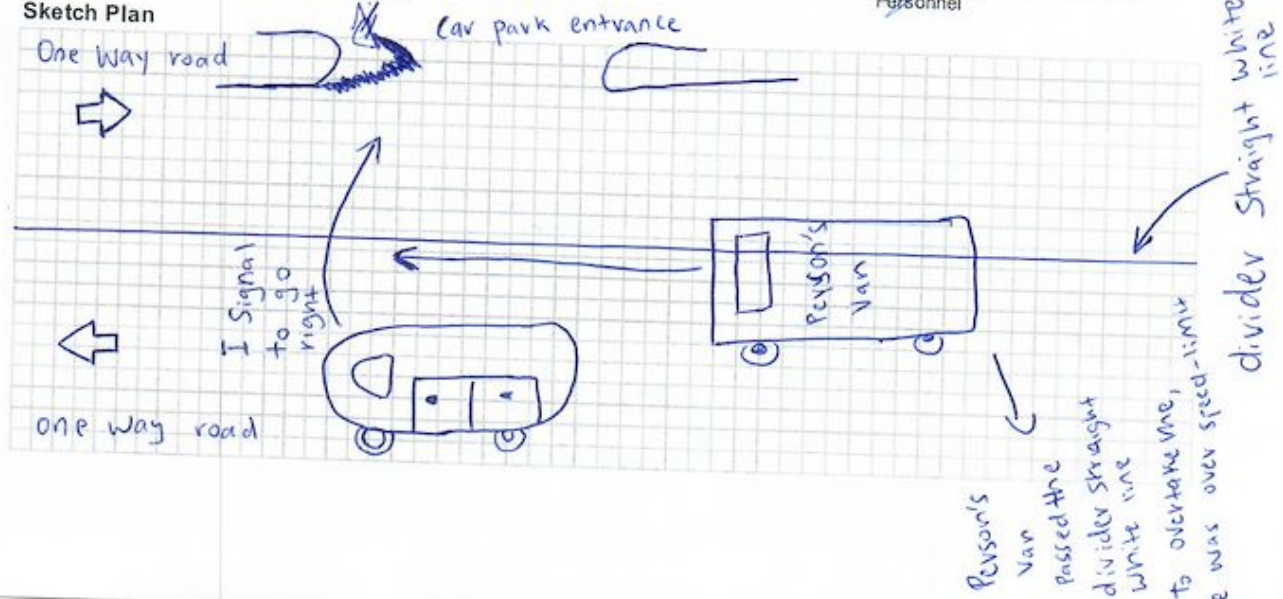

Describe Circumstances of the Accident

Statement regarding accident at S560521. This is my account of the unfortunate incident that occurred at 521 Ang Mo Kio Avenue 5. I was approaching a car park entrance on a road divided into 2 lanes by a single white line. One ~~of the~~ designated for vehicles travelling straight in one direction and the other for vehicles ~~the~~ travelling in the opposite direction. Under no circumstances there should be any overtaking.

As I approach the car park, I carefully signalled my intention to make a right turn. I was fully aware of the traffic conditions around me and took every precaution to ensure a safe maneuver. I waited patiently for all oncoming traffic in the opposite lane to clear, and then I checked my blind spot to confirm that it was safe to proceed. When I glanced behind, I noticed a van approximately 5 car lengths away. I had been signaling my intention to turn right for an extended period, making it abundantly clear that I intended to turn right into the carpark. Given the ample distance between my vehicle and the van, any prudent driver would have ~~the~~ recognised my intent and allowed me the space to complete my turn safely.

However, the van driver, who was travelling at an alarmingly high speed, ignored my signal and recklessly attempted to overtake me by cutting across the single white line dividing the lanes. This maneuver was not only dangerous but also illegal, as it is a one-way road with strict no-overtaking rules. Despite my careful driving, the van collided with my car as I was in the process of turning right.

Upon impact, my head jolted sharply to the left. The collision left me with persistent headaches and visible scratches. The entire incident was traumatic.

I want to remind everyone that the driver is impatient, reckless and going over speed limit. He is doing illegal activities. I am a victim.

Police Report Regarding Accident at 521 Ang Mo Kio Avenue 5, Singapore 560521

I am filing this report regarding a traffic accident that occurred at 521 Ang Mo Kio Avenue 5. As I was driving towards a car park entrance on a road divided into two lanes--one designated for vehicles traveling straight in one direction and the other for vehicles traveling in the opposite direction--I signaled my intention to make a right turn.

I exercised caution by signaling well in advance and waiting patiently for all oncoming traffic in the opposing lane to clear. After confirming that there were no vehicles approaching from the opposite direction, I checked my blind spot and noted that a van was approximately five car lengths behind me. Given the ample distance and the fact that I had been signaling for an extended period, any prudent driver would have recognized my intention to turn right and allowed me the space to do so safely.

Unfortunately, the van driver chose to ignore my signal and, traveling at an excessively high speed, recklessly attempted to overtake me. He cut across the single white line dividing the lanes, despite it being a one-way road with strict no-overtaking rules. As I was in the process of making my right turn, the van collided with my vehicle.

The impact was severe and sudden, resulting in a loud, jarring noise and causing my head to snap sharply to the left. I have since been experiencing headaches and have sustained visible scratches from the collision. The incident was both traumatic and distressing, and I firmly believe that the van driver's reckless behavior was the sole cause of this accident.

Regrettably, I do not have a car camera installed in my vehicle, which would have provided clear evidence of the events as they unfolded. Therefore, I respectfully request that the police thoroughly investigate this matter, as I believe the van driver's actions were dangerous and unlawful. I am confident that a detailed investigation will demonstrate my careful and lawful conduct in contrast to the van driver's recklessness.

Your assistance in this matter would be greatly appreciated, and I hope for a fair and just resolution to this case.
