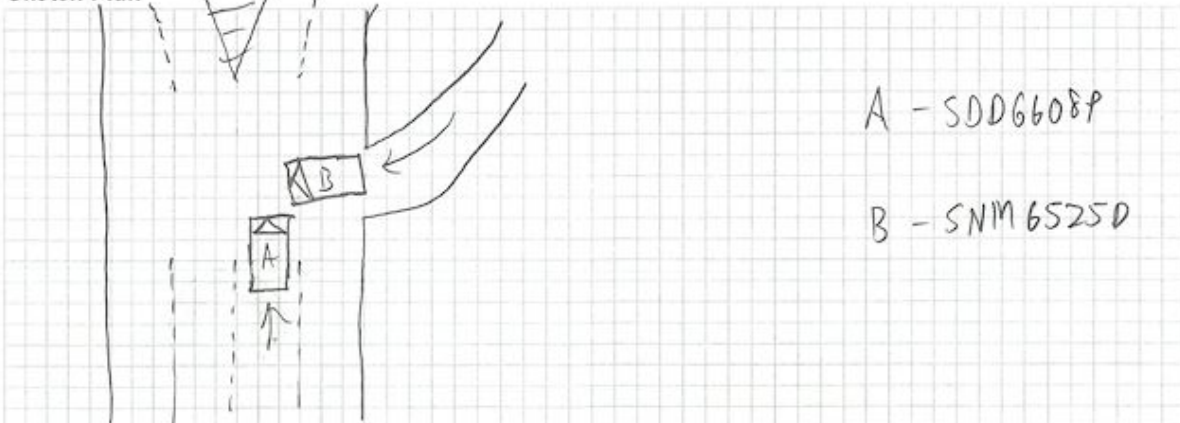



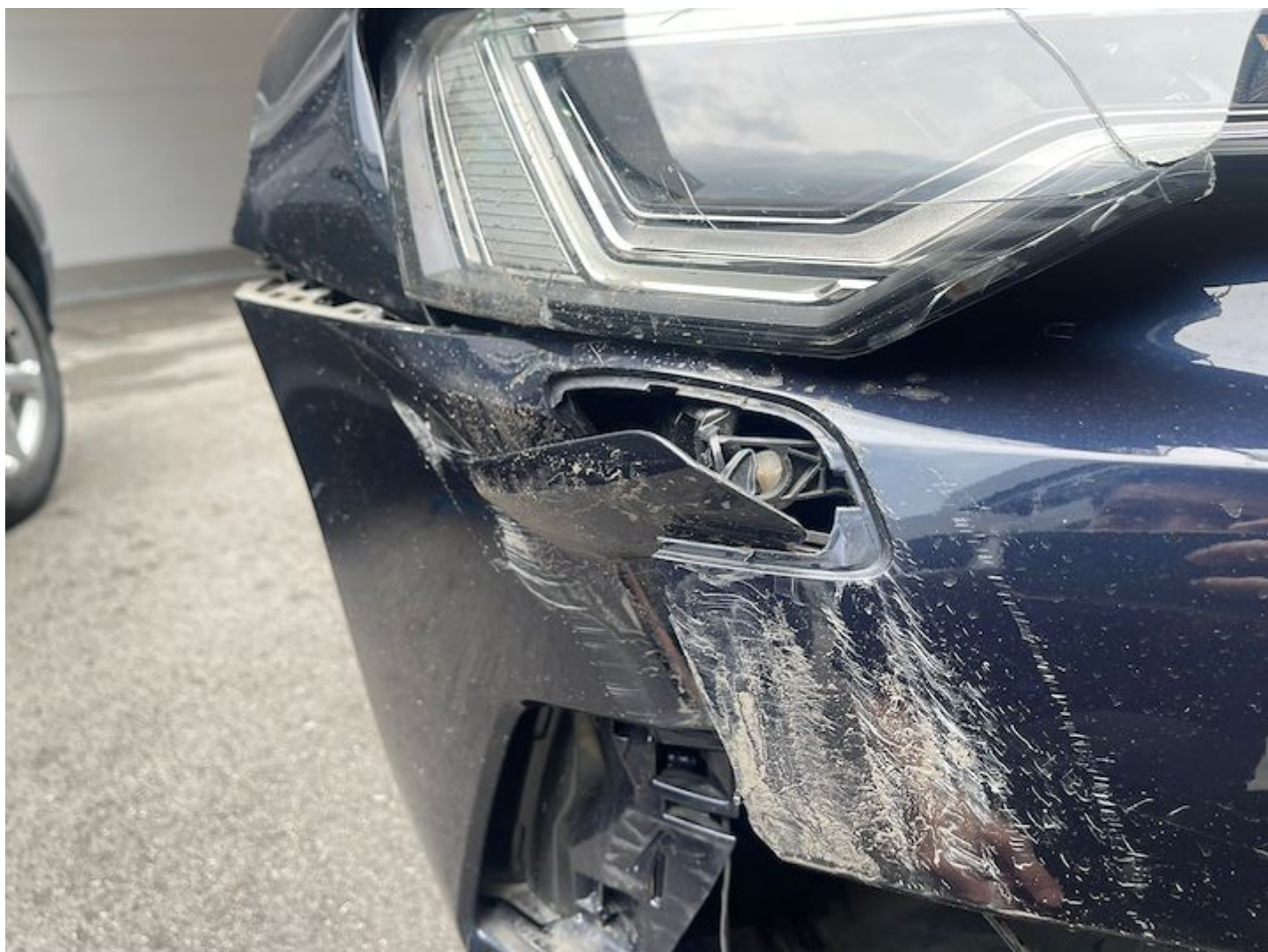

**Brief Details.**

Travelling on Sentosa Gateway towards Telok Blangah Rd, before the entrance of the underpass.

I had intended to enter the underpass and was driving on the 2nd lane from the right. I was driving straight, around 45 to 50km/h, and the car that I collided with (SNM6525D) was making a U-turn from my right, my car hit the side of his car's bonnet. I did not see the car until the very last moment and immediately did an emergency brake as soon as the car came into my view midway through its U-turn. I honestly did not notice that it was a signalised road until I recovered from the initial shock from the crash and exited the car to register my surroundings.
