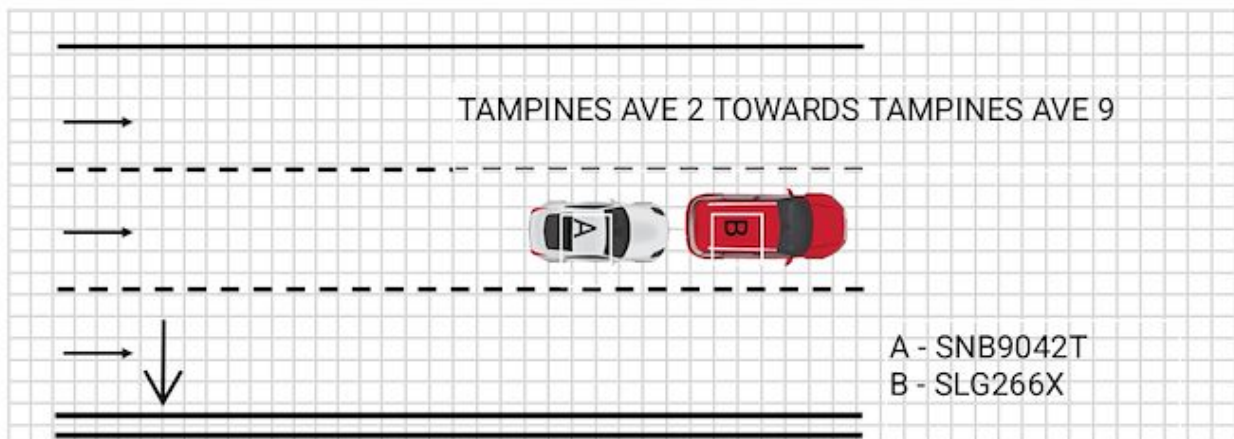

**Brief details.**

On the 23/08/2024 at about 2000hrs, I was cruising along Tampines Ave 2, towards Tampines Ave 9 when the traffic lights turn red. I slowed down and eventually came to a stop. My vehicle (SNB9042T) had stopped relatively close to the vehicle in front (SLG266X) but there was no impact. Shortly after, the driver came out of his vehicle and informed that I had collided with his car. However, when I got out of the vehicle and made a check, there was a gap between both vehicles and there are no damages. He mentioned that there are scratches above the bumper. The damages could not have been caused by me as there was no collision.

The following day, the driver introduced himself as Erwin (96808664), contacted me on WhatsApp, informing me that he had sent his car to a workshop and there are some scratches on his bumper but did not specifically say where. The repairs cost SGD\$250.00 and he asked if I wanted to settle privately. At about 1610hrs, I gave Erwin a call, trying to explain the situation but as the conversation went on, he said 'Eh fuck you la, just listen to me when I talk'. I informed my accident team, and they advised to lodge a police report.
