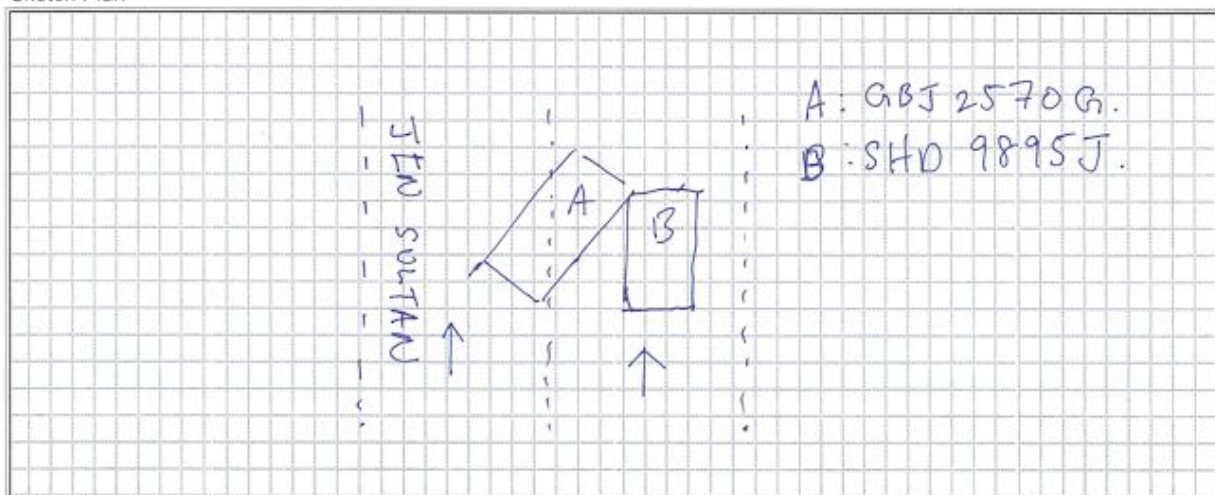

Describe Circumstance of the Accident

At about 12:25am on 26 July 2024 I drove along Jln Sultan and signaled right to change lanes. As I was easing right into the lane, a taxi driver by 67 year old Mr Toh Keng Hock hit the front right portion of my vehicle. Although it was night-time, visibility was good and the road was dry with no rain.

It would seem highly likely that Mr Toh perhaps due to driving fatigue or possibly on account of seniority of age made a slight oversight and due to human error knocked at a slight angle the front of our vehicle.

From the photos you will notice the slight dent that occurred due to the collision.

I was unable to retrieve video recording as there was no SD card in my recorder.

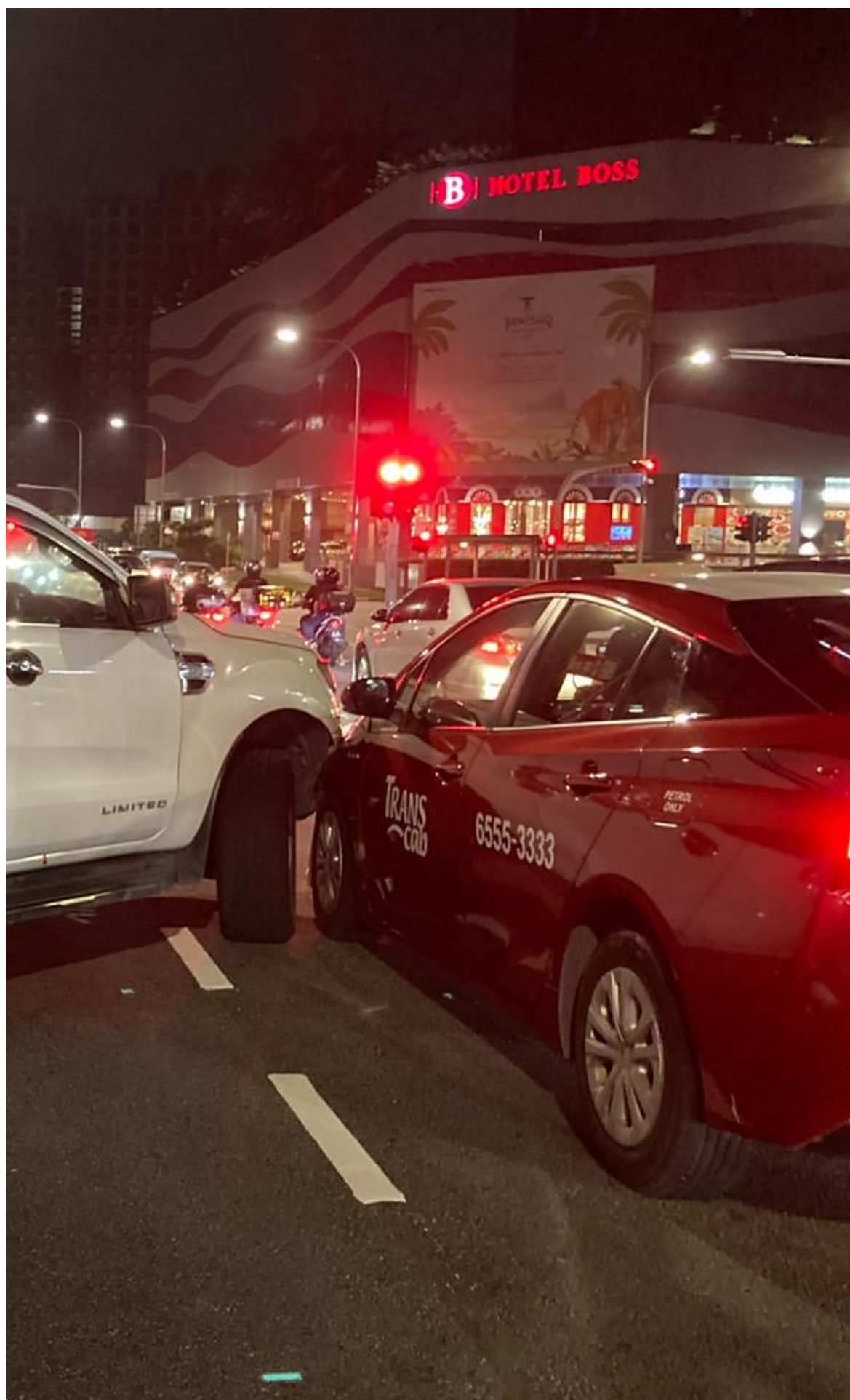




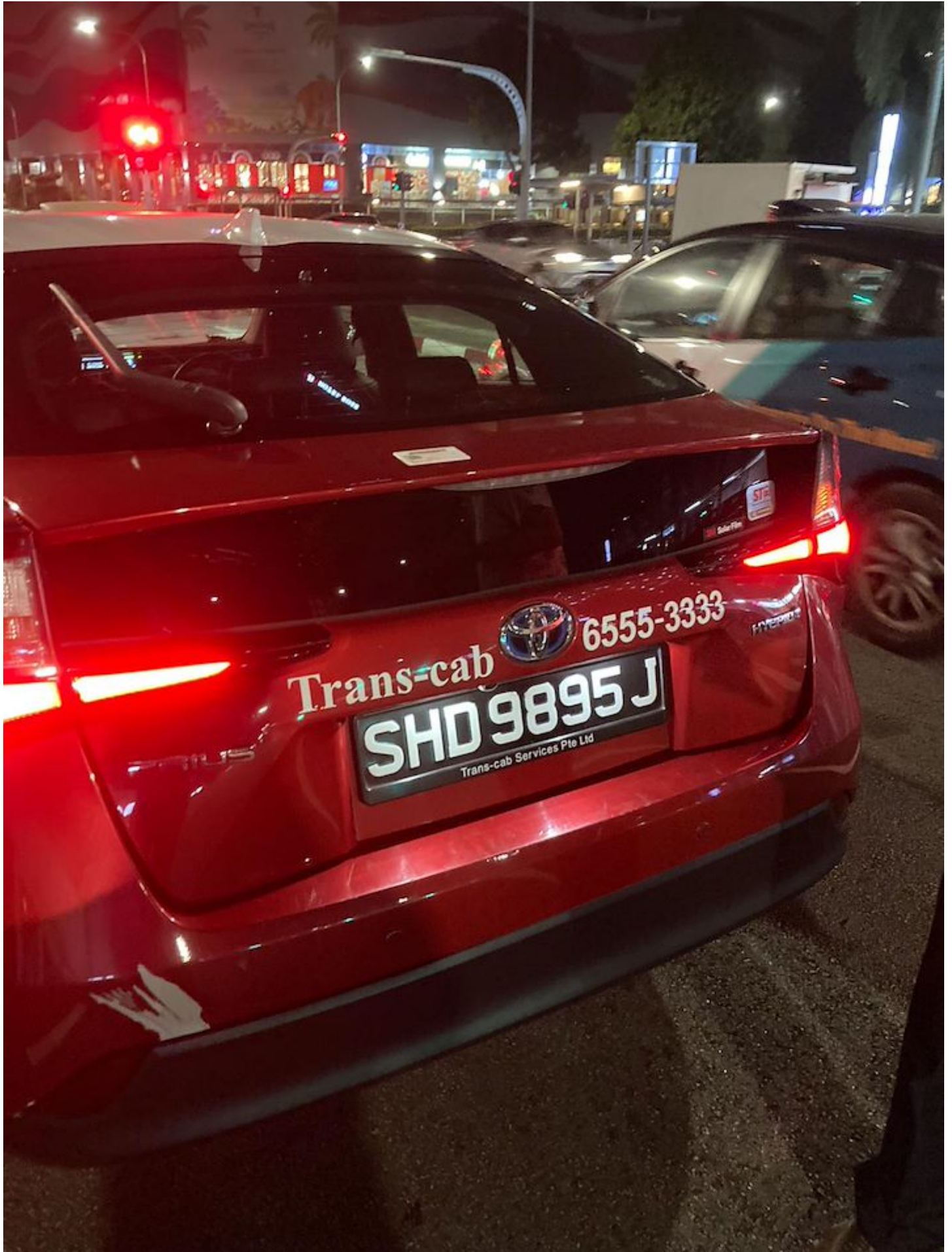
