


Figure A-1: MID34591Arriving at National Archives Singapore Carpark




Figure A-2: MID34591 Performing a 3 Point Turn at the Empty Carpark




Figure A-3: MID34591 Reversing towards the Sheltered Parking Lots




Figure A-4: MID34591 came into contact with the Overhead Louvre Grill
