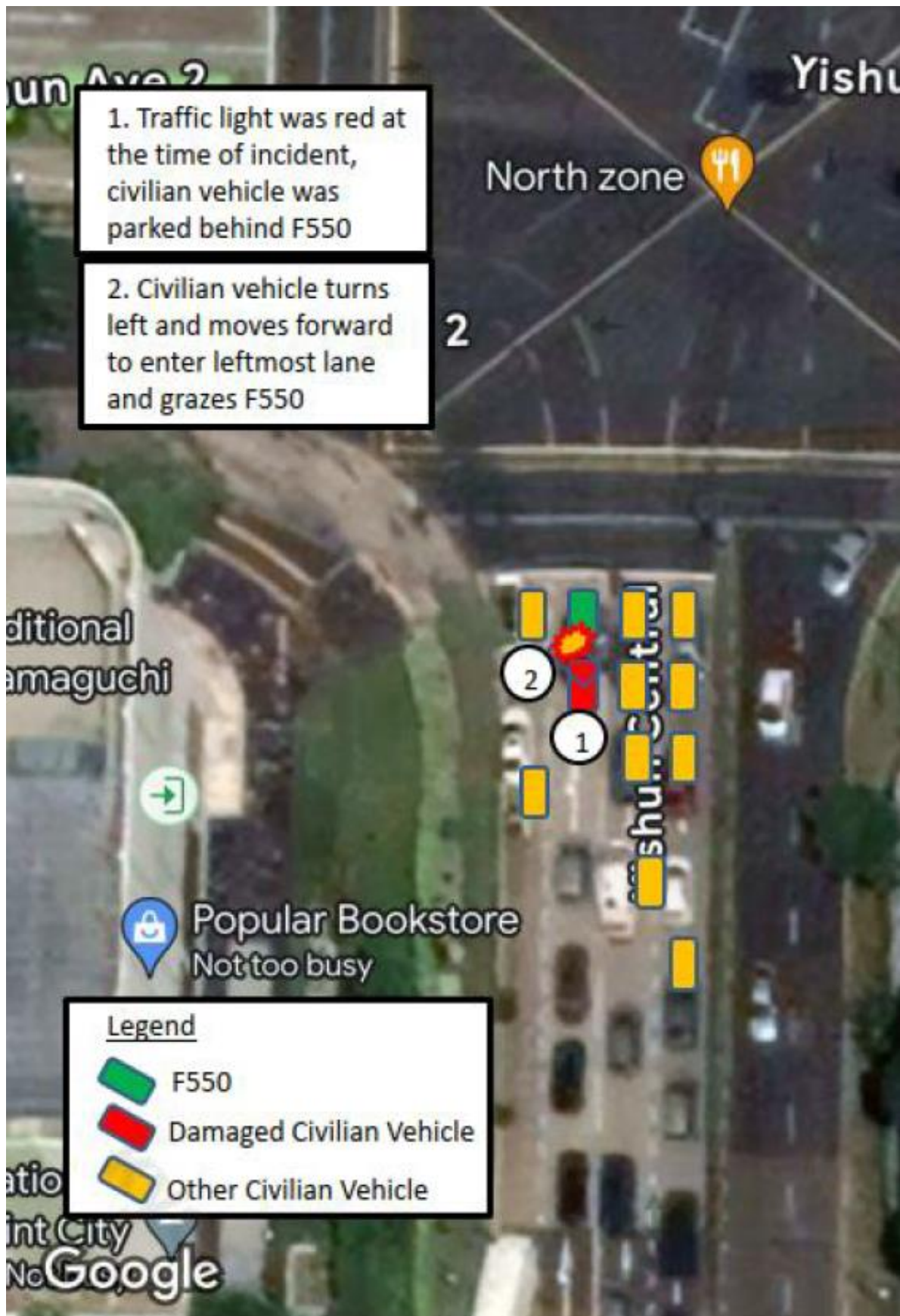

Brief Details.

On 18 June 2024, I (MR YEOH CHIN FONG) was a trainer from eLC Pte Ltd onboard the Ambulance F550, 34825MID. I was taking a trainee, LCP LEONG WENG KIN (TXXXX135J) for his Night Public Road Driving training from Sembawang Camp to Khoo Teck Puat Hospital and back to Sembawang Camp.

At around 2005hrs, 34825MID was stationary and waiting at the traffic junction in red of Yishun Central towards the direction of Yishun Ave 5 on lane 3 out of the 4 lanes. Lane 3 is a straight or turn left lane, while lane 4 is a left turn only lane.

When the left turning green arrow came on for the traffic turning towards Yishun Ave 2, I felt a bang on the left rear and saw a civilian car, SLP6030Y has side swiped with 34825MID. I immediately asked LCP LEONG if he was ok before I got down to check on the civilian car. I subsequently informed my Conducting Officer, MR MOHAMED NORAZMAN BIN MOHAMED HAMIN about the incident.
