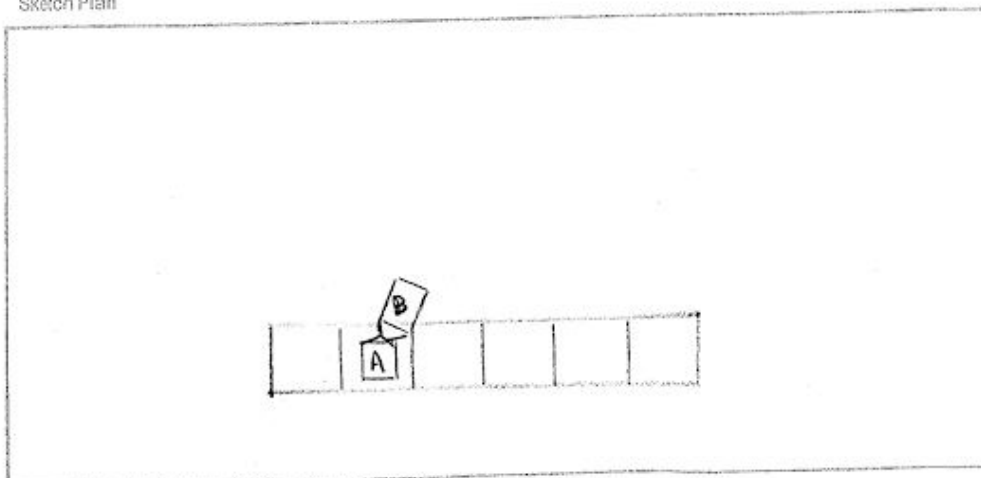

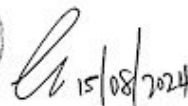
Sketch Plan

Brief Details.

On 14/08/2024, at about 1713hrs, I parked my car SLN9039P at the open space car park of Jurong Play Grounds (2 Jurong Gateway Rd) as I was sending my daughter for swimming lessons. That was the last time I saw my car intact. I subsequently returned to my car and left the location at about 1820hrs and I did not notice anything amiss. At about 2000hrs, when I alighted from my car after parking my car at 815 Choa Chu Kang Ave 7, I discovered that my front bumper had protruded out. I was puzzled as I do not recall having any collision while driving my car. I then noticed a crack and large patch of scratches on my right front bumper. I immediately checked my in-car camera and I found out that at about 1811hrs, at the open space car park of Jurong Play Grounds, a silver Honda GetGo car SLR1172T had collided onto my car while trying to park head-on into the parking lot beside my car. The Honda car had actually collided onto my car a few times while adjusting itself during parking. Subsequently, my camera captured a male, who was wearing a black t-shirt and cap, asking the female driver, who was wearing a brown top, to alight from the car. The male subject then took over the steering wheel and parked the car into the lot beside my car. Both of them, with another lady in white carrying a child, then came and looked at my car. However, they did not attempt to inform me about the accident by leaving any note or wait for me to come back. They left the location

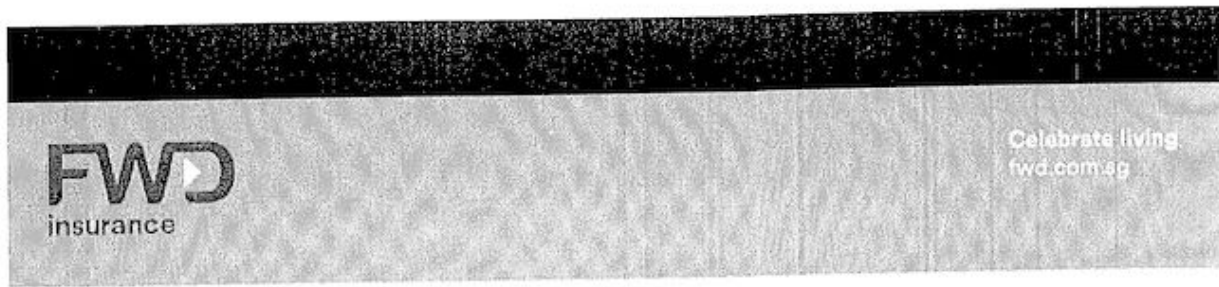
