

4. REPLACEMENT VEHICLE

- b. The Hirer shall be responsible for the fuel and still adhere to clause 5 for the replacement vehicle
- c. Insurance excess will also apply to the replacement vehicle
- d. If the replacement vehicle is not available pursuant to clause 6(a), Rental will be pro-rated by The Owner on a case-by-case basis.

5. USE OF VEHICLE

- a. The Hirer may use the vehicle for business solely, unless otherwise advised/assigned by The Owner. - b. The Hirer shall be responsible for the petrol, electronic road pricing (ERP) charges parking charges and traffic /parking related fines provided by the other fees arising from the use of the vehicle or replacement vehicle provided by The Owner throughout the period of the agreement.

- d. No additional driver(s) other than The Hirer is allowed to drive the vehicle, nor can the vehicle be sub-let to others without prior approval from The Owner; otherwise The Hirer shall be deemed to have breached the agreement resulting in the forfeiture of the deposit and shall still be liable for all other obligation to The Owner under the agreement.

7. INSURANCE(CON'D)

- b. Non-Waiver Excess & fees
 - i. The Hirer will be responsible for the full amount of the insurance excess & fees prior to making an accident report.
 - ii. The insurance excess will only be refunded to The Hirer upon confirmation from the insurer on the percentage of liability on The Hirer


