ON 04/09/2024 AT AROUND 12:15 HRS, I WAS DRIVING VEHICLE A BEARING REGISTRATION (SH7883E) ALONG BALESTIER RD. I WAS EN-ROUTE FROM ROYAL SQUARE HEADED TOWARDS IPOH LANE TO DROP OFF 3 TAXI PASSENGERS. I WAS TRAVELLING STRAIGHT ON LANE 2. FURTHER AHEAD, THERE WAS ROAD WORKS. I THEN INTENDED TO MAKE A LANE CHANGE TO LANE 3. AFTER CHECKING CLEAR, I THEN PROCEEDED TO MAKE THE LANE CHANGE. SUDDENLY, THERE WAS AN IMPACT FROM THE LEFT SIDE. VEHICLE B BEARING REGISTRATION (SNS4826S) HAD MOVED UP AND COLLIDED FRONTAL RIGHT TO LEFT FRONT OF VEHICLE A. VEHICLE A HAD DAMAGE ON THE LEFT FRONT PORTION. NO INJURY AT THE TIME OF ACCIDENT.

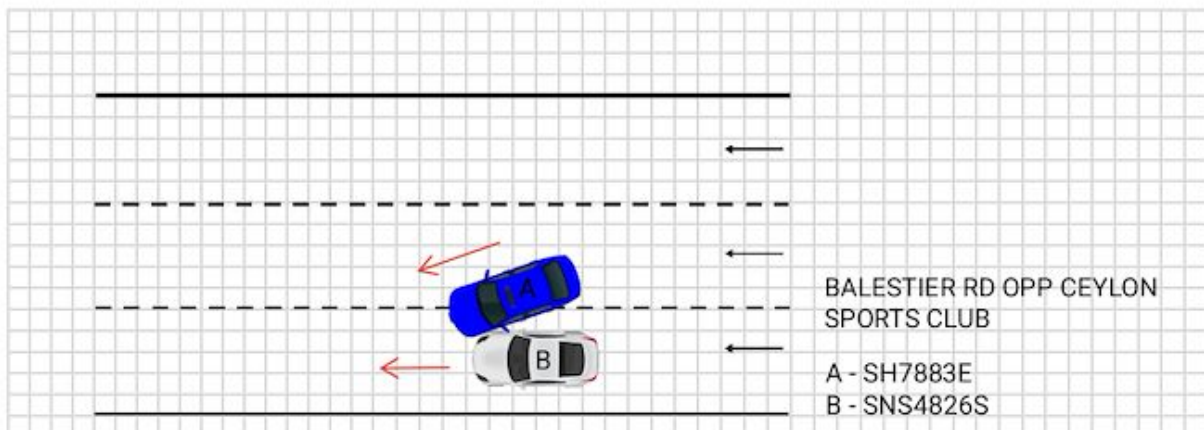
