



Describe Circumstance of the Accident

On 8th September 2024, at approximately 16.30pm, my vehicle was parked and stationary in the multi-story carpark at the Rochester Residence. I became aware of the accident only on the 9 September 2024 after finding a note left by the owner of the vehicle SLG 6764K, informing me that their vehicle had collided with mine. Upon reviewing my car's video recording, I was able to verify that the collision occurred at the indicated time.

The footage shows the vehicle with licence plate number SLG 6764K collided my parked car, causing damage to the right bumper (front). My car was unattended at the time of accident, and no injuries were sustained.

I would like to proceed with filing an insurance claim for the damages. The relevant video footage has been attached for verification purposes.
