## **Brief Details.**

On 10/09/24, at around 2006hrs, I was at Woodlands checkpoint heading to Malaysia from Singapore when a black Honda bearing license plate SMM9322P tried to cut into my lane from the left. This black Honda continued to drive into my lane, however, I did not want to let him cut into my lane, and I did not give way. He kept aggressively trying to cut into my lane, however, I did not give way for him. On the left lane, there was an obstruction in the road, and he tried to force himself into my lane, however I did not give way, and the front of his bumper hit the left side of my car.

Once I realised that my car had been hit, I turned on my hazard lights and stopped by the side of the road. The driver of the black Honda exited his vehicle and started scolding me, and I got out of my car as well to confront him. however, there was no assault or threat of assault. All this footage was captured on my dashcam. Nobody was injured, however, my car was dented and scraped towards the middle on the bottom of the left side doors. The area around my left rear wheel was also scratched. The area around my front left door hinge was also lightly scratched. The black Honda also suffered light damage on the front right side of the bumper. The 5 passengers in my vehicle at the time are my friends.
