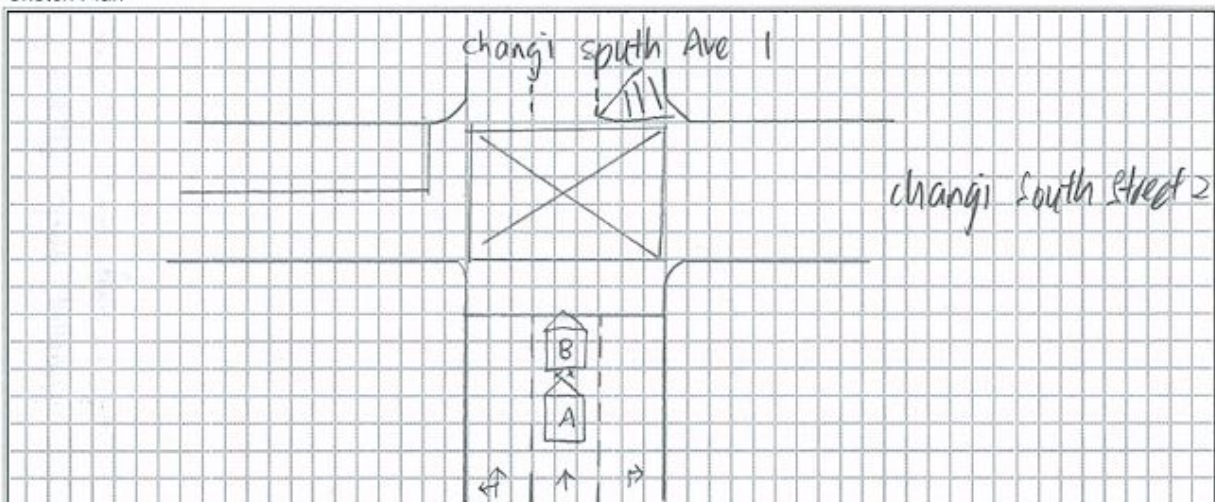

Sketch Plan



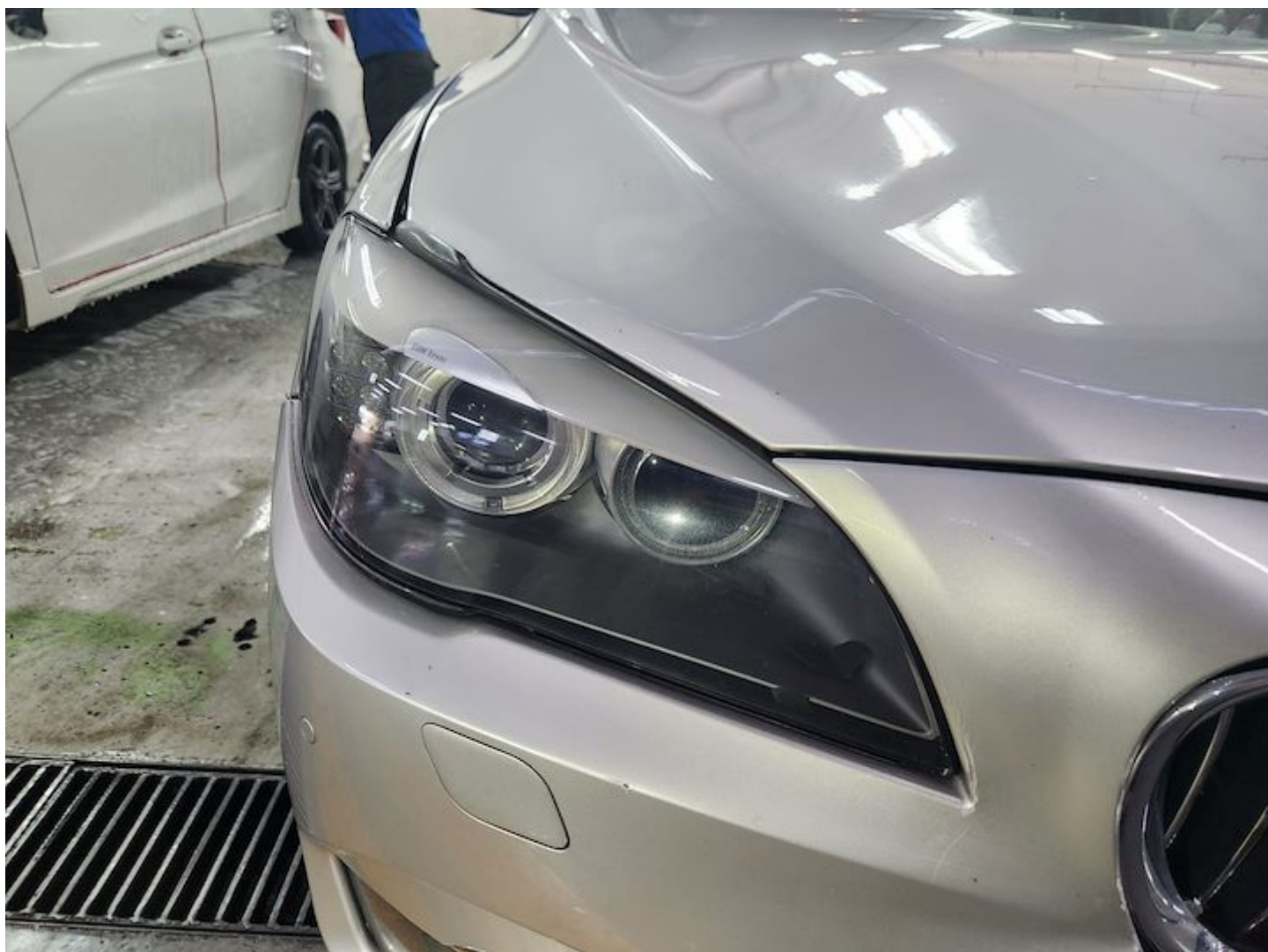
