

Brief Details.

On 20th September 2024, 8am, I was driving SLX3365J along 16 tai seng street.

My vehicle is moving in the direction of 18 tai seng(mall). As i am moving straight at 50kmh, I observed there is a parked van (GBL 647Y, same traffic direction) and a sedan car (skx2210R, opposite traffic direction) which is having the intention to parallel park with it's hazard light on when my vehicle is 30-40m away.

While pass in the middle of these 2 cars, SKX2210R drive in reverse and turns it's direction to facilitate it's parallel parking and rear right ended my car(slx3365j) with it's right front.

This impact causes my car (slx3365j)to change direction and hit gbl647Y in it's rear right with my car front left.

Damages to gbl647r(van):

- van driver suffers light neck injuries and sent to hospital. No visual injuries.
- van's right rear bumper and rear light is light damaged.

Damages to slx3365j(my car):

- no visual injuries to driver
- front left, severely damaged with dislodged wheel
- rear right, bumper and fender dislodged , Moderate damage

Damages to skx2210r(sedan car):

- no visual injuries to driver
- front right headlight fender lightly damaged.
