
SKETCH PLAN

Brief Details.

On the above mentioned date, time and location, I was driving my vehicle, SGB2209J at the carpark near block 864A Tampines St 83. While I was reversing my vehicle, visibility was bad and I accidentally collided onto two parked motorcycles (FBS7241B & FBV9430T). The motorcycles dropped which caused a domino effect onto other motorcycles which caused them to fall as well. The other motorcycles are FW17K, FBP2345J, FBT2722H and FBT4668T. I called my friend to assist me. He came and we carried the motorcycles up. I noticed that for FW17K, the exhaust pipe cover was dislodged. I placed the cover on the box.

I have yet to leave a note and I will be doing so after lodging this report. I have an inbuilt car camera which captured the accident.
