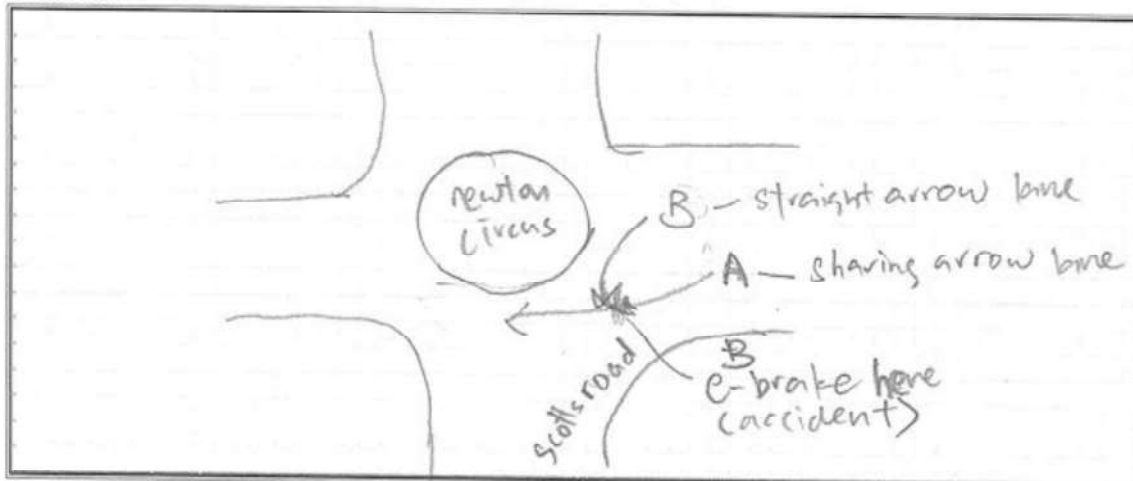

**Sketch Plan**



Traffic Accident between Private Car SND680A and ComfortDelGro Taxi SHC7537L at Junction of Newton Circus and Scotts Road on 21 Sep 2024 at 6.36pm

#### Accident Details

- I am the driver and owner of SND680A. I have a video footage to support my claims, but I am not sure if you can view the video into this report. Please contact me at 97524223 if you need video evidence or more details.
- The weather at point of accident was clear and the road was dry. My wife, son, daughter and helper were in the car with me when the accident took place.
- Taxi accelerated and abruptly cut into my car's lane from my right to turn left into Scotts Road at the last minute. My car had the right of way to turn left or go straight on this roundabout. Taxi's lane can only go straight.
- Although Taxi did not signal, I slowed down almost to a stop to let Taxi overtake me and complete his illegal turn. Taxi almost caused an accident here, but I was able to avoid hitting him.
- After accelerating to overtake me at a high speed, Taxi e-braked to a complete stop immediately after being in front of me, in the middle of the junction and when the road ahead was clear. After reviewing the video footage, it does not seem that he has any good reason to e-brake suddenly to a complete stop. I could not have anticipated his sudden complete stop e-brake and my car hit Taxi's left rear.
- I asked the passengers in the Taxi if they were injured and they said they were not injured.

#### Potential Scam

- Taxi Driver got out and immediately asked if I wanted to privately settle and I agreed to discuss. He seemed experienced in such situations and shared with me of similar past accidents where another driver hit his rear.
- I told Taxi Driver that he had turned left when he does not have the right of way. He was not interested to discuss and told me that I had hit his rear and asked if I am keen to proceed with a private settlement.
- I was in a state of shock and thought that I am 100% liable because I had hit his rear. After reviewing the footage, I think I should not be liable for his act of dangerous driving.
- Taxi Driver said he is a relief driver and called his Taxi Hirer to speak with me. I only know Taxi Hirer as Mr Tan, and spoke to him on the phone.
- Taxi Hirer asked for SGD1000 as private settlement. I tried to negotiate with him and offered SGD400.
- Taxi Driver persuaded me to increase my offer to SGD600 so that he can 'help' me negotiate with his Taxi Hirer. I agreed.
- Taxi Driver called Taxi Hirer and came back to inform that the offer remained at SGD1000.

- Whenever I refused to pay SGD1000, both Taxi Driver and Hirer reminded me that this is a good offer. It is going to be a lot cheaper than if they claim many items against me (eg, loss of income, rental, repairs, etc). It sounded threatening.
- All parties agreed to report this accident to respective insurance companies, and we left the accident location.
- Taxi Driver called me on my phone at 9.09pm on 21 Sep 24 to ask me to reconsider the SGD1000 offer. I rejected.
- After reviewing the footage and recollecting what happened (accelerated to cut into my lane at the last minute to make a left turn even when he has no right of way + e-brake to a complete stop in front of me + persistence in asking for an astronomical amount to privately settle this accident that was created by Taxi Driver himself), I am quite convinced that this was a scam for them to earn SGD1000. The website to report traffic offences is currently down, hence I am making this police report.
