

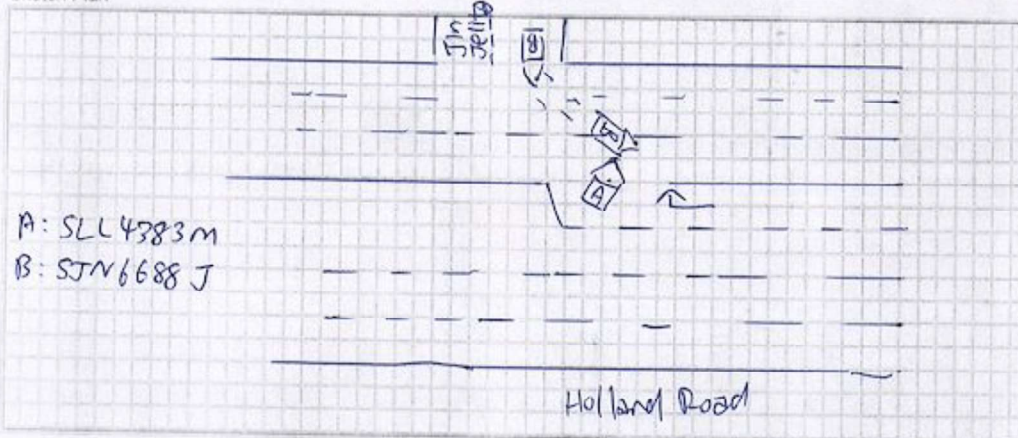

Sketch Plan







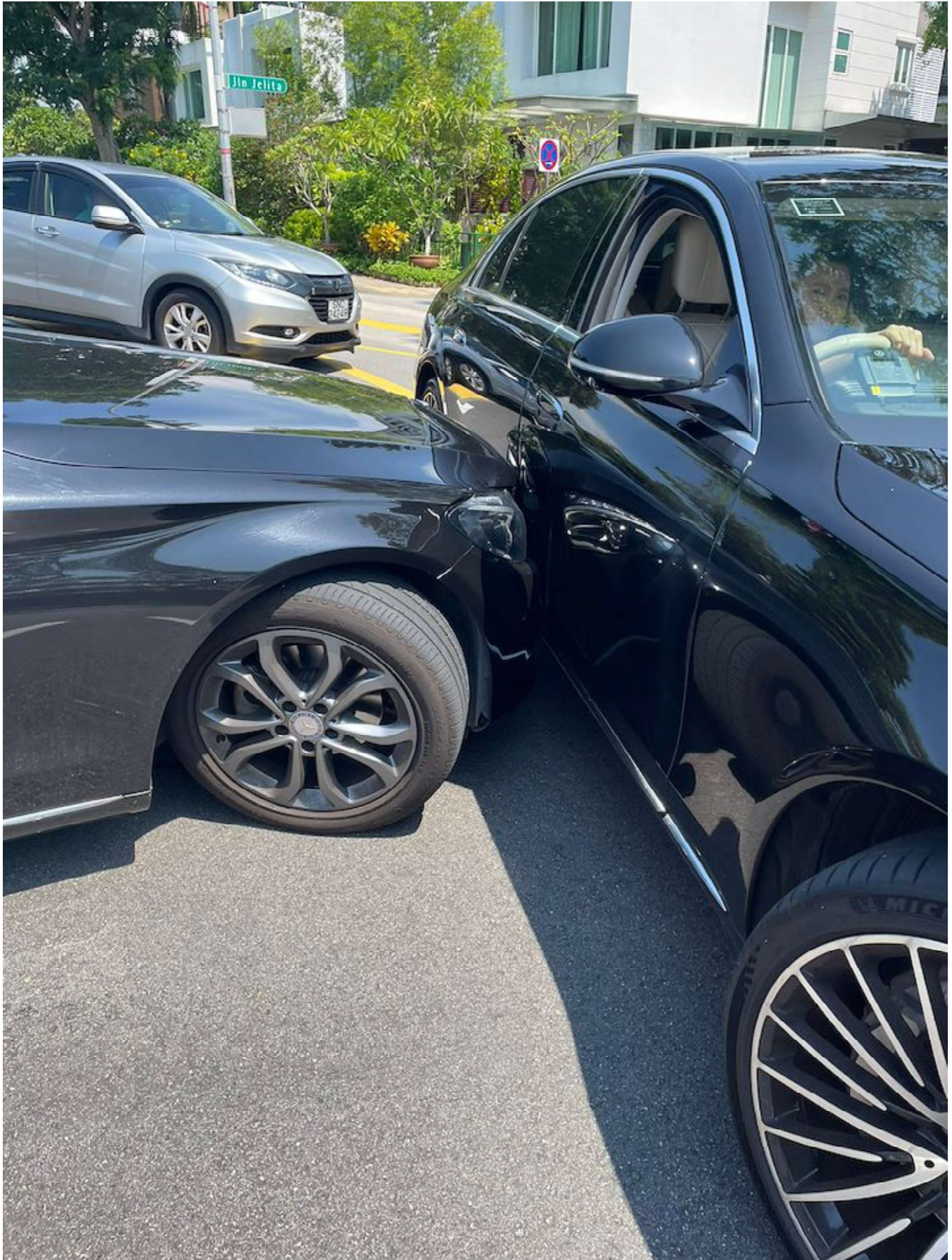
