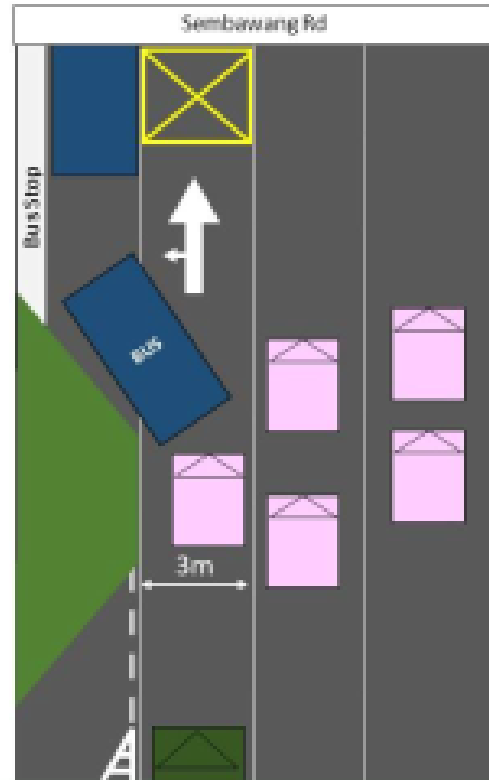


Figure A-1: Overview of Incident Site

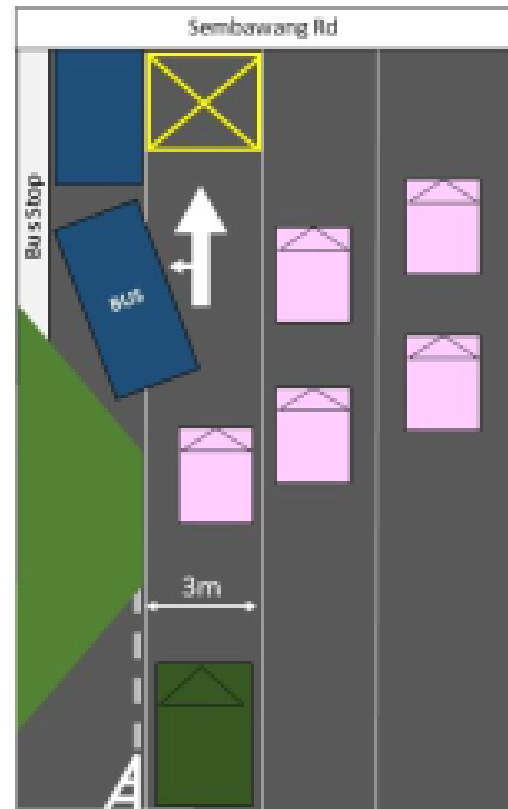

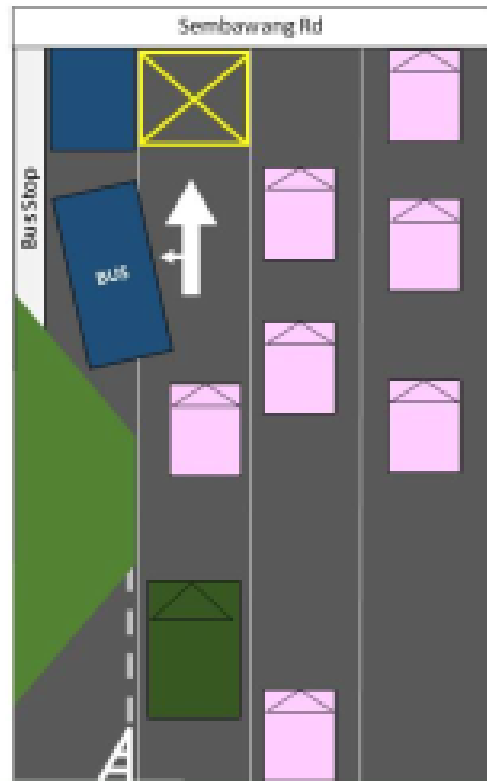

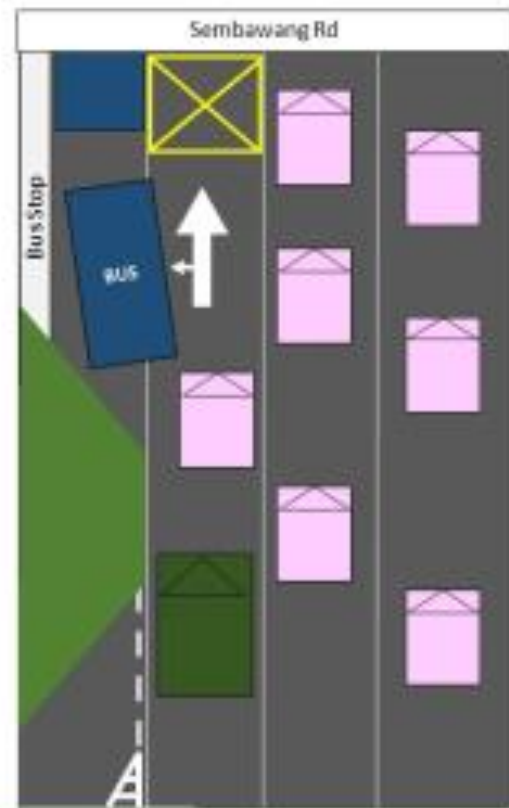

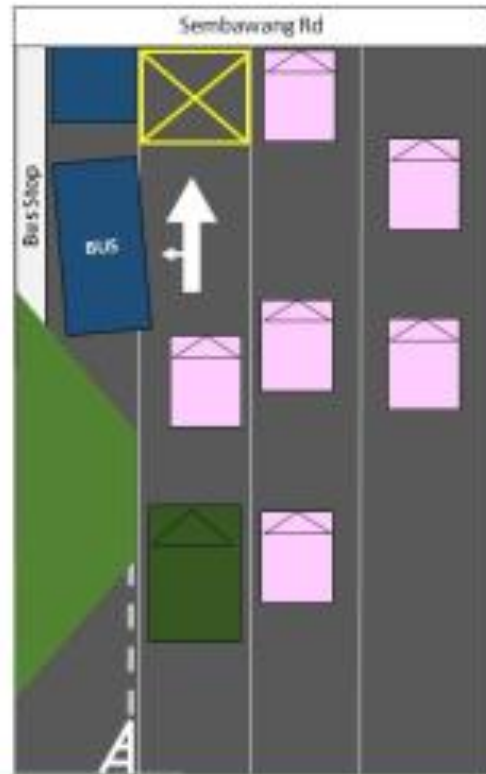

Schematic Diagram of Incident



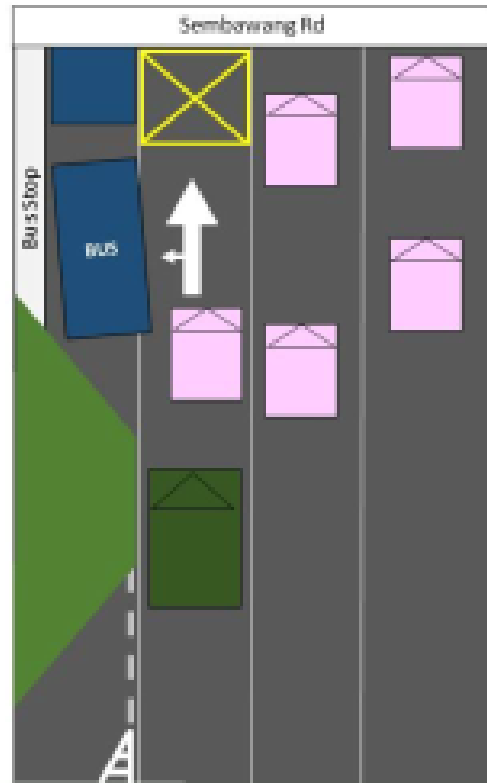
BUS (SMB3161J) comes to a halt.

Schematic Diagram of Incident



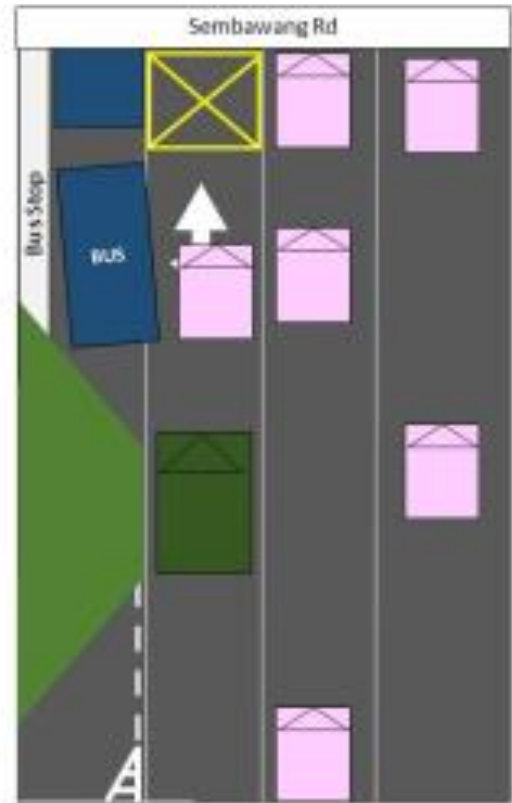

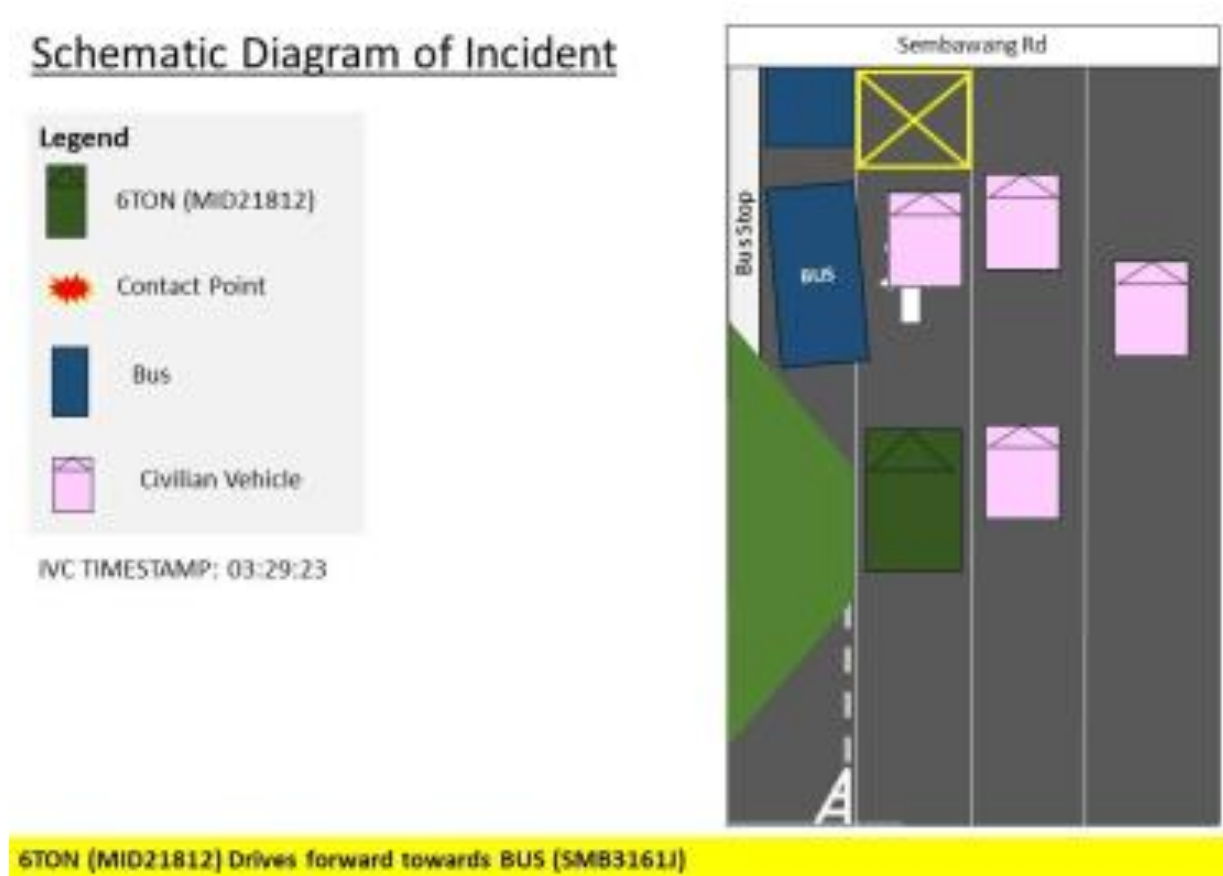


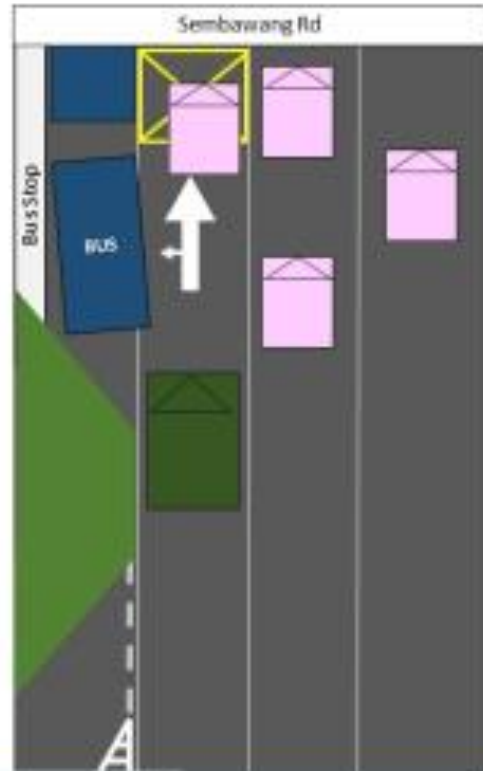

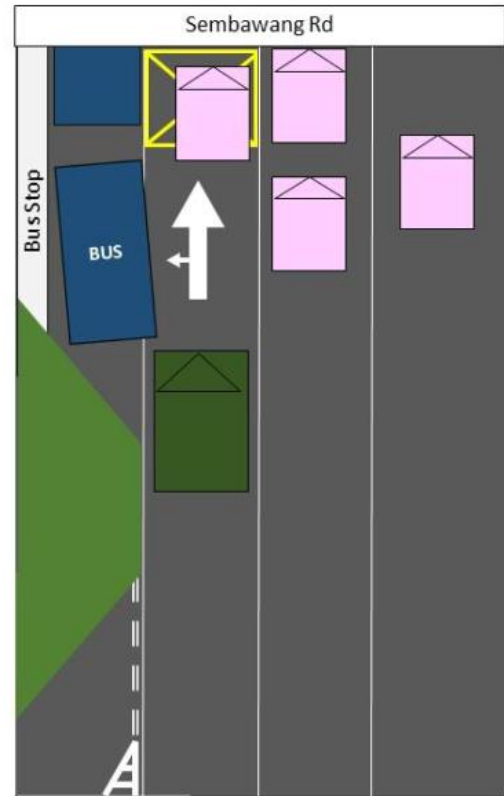

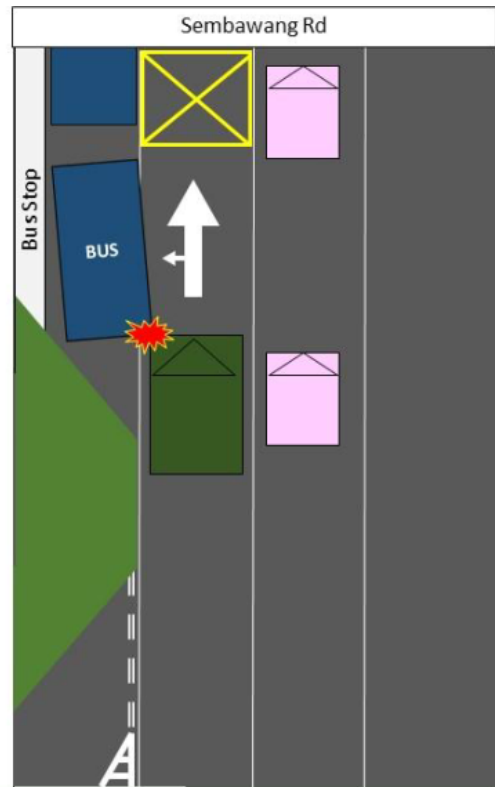




Figure B-13: Close-up View of Damages to SMB2161J
