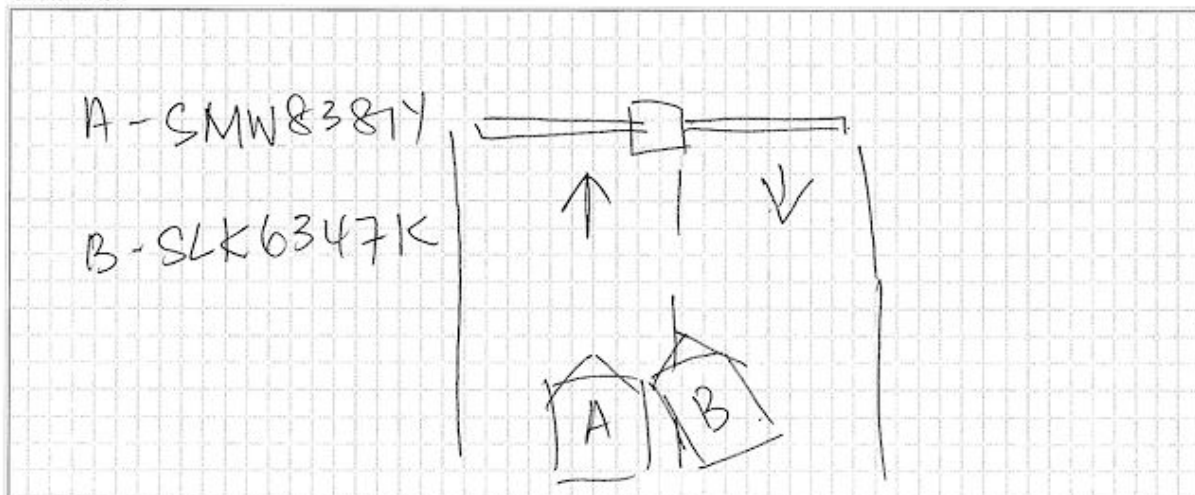

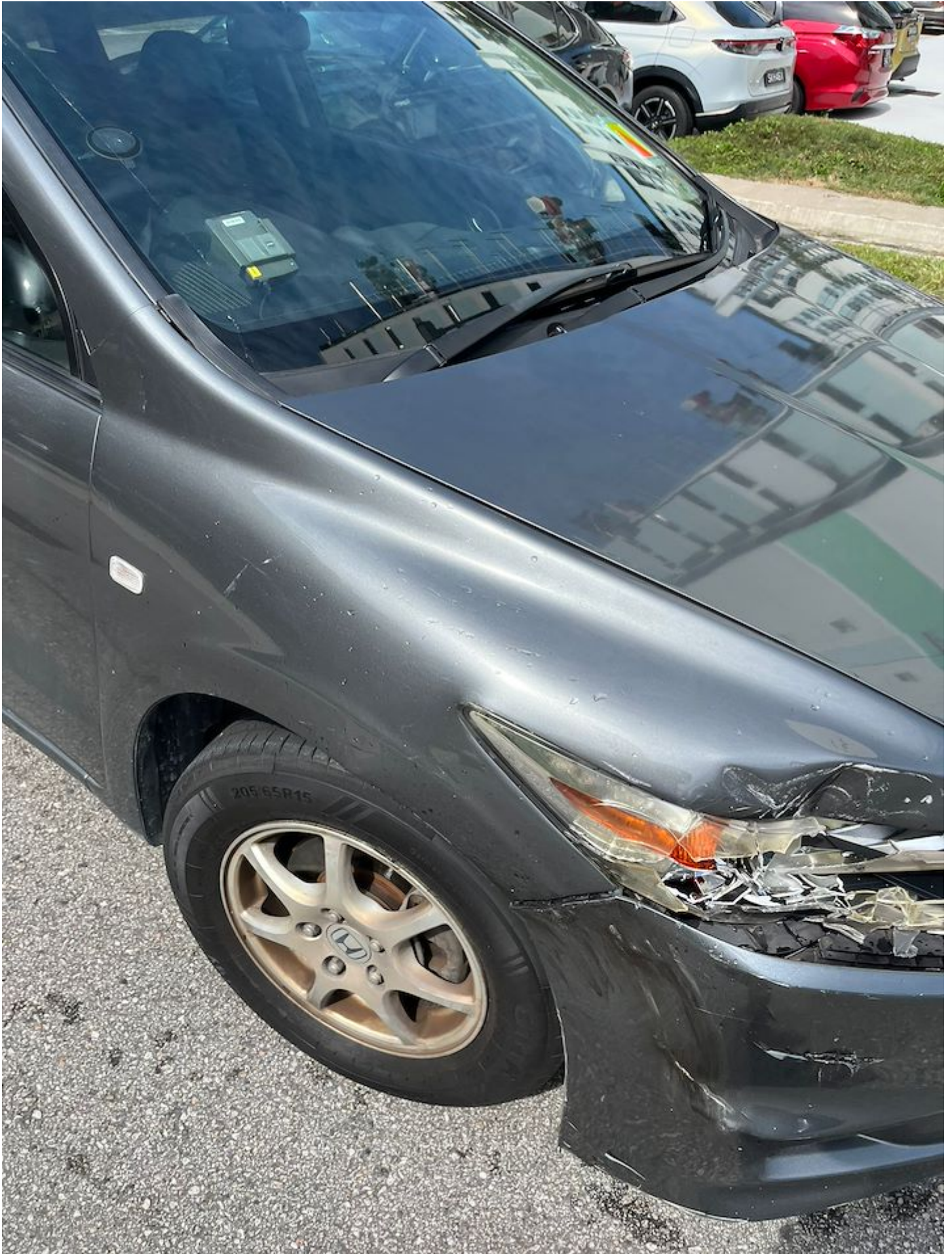

Brief Details.

I have pictures of the damage done to both vehicles and a map which will describe the entire incident.

The incident happened in the carpark of Blk 267, Tampines St 21. After turning left and moving forward towards the gantry to exit the carpark, a vehicle moving at a high speed swerved in and hit my vehicle at my front right tyre. My vehicle was already straight, cleared of the left turn and moving straight towards the gantry when the collision occurred. The vehicle which hit me was in the other lane (opposing traffic) after hitting me. I was moving at a reasonable speed of 10km/h.
