Brief Details.

On the above mentioned date, time and location, My wife who was the pillion and I the rider was involved in a traffic accident while on our way from MOM to our workplace on our motorcycle NCS1642. While riding on the road at BKE towards SLE on lane 2, the left rear of my bike was side-swept by a Hyundai comfort delgro blue taxi SHA4339Y. My wife and I fell on our left and our bike was thrown away from us by the road shoulder.

Passer-by called ambulance. Two ambulance came to the scene and took me and my wife to Khoo Teck Puat Hospital. Police came to the scene and no case card was given. The driver parked his car on the road shoulder nearest to the 4th lane. The damages to my bike is as follows, the front of my bike is broken. The damages to the taxi is the front right bumper. The injuries my wife have sustained are left elbow full thickness abrasion with olecranon avulsion fracture and underwent wound debridement and excision biopsy of left forearm granuloma.
