WHILE DRIVING ALONG DECK 2A OF 931A HOUGANG ST 91 MSCP, I SLOWED DOWN AND STOPPED TO GIVE WAY A VEHICLE WHO WAS STATIONARY WITH HIS HAZARD LIGHTS ON, GIVING WAY TO ANOTHER VEHICLE EXITING OUT OF A CARPARK LOT. SHORTLY AFTER THE FRONT RIGHT OF VEHICLE (B) BEARING REGISTRATION NUMBER SLK3550J COMING UP THE CARPARK SLOPE ONTO DECK 2A HIT ONTO THE REAR LEFT OF MY VEHICLE. NOBODY WAS INJURED.

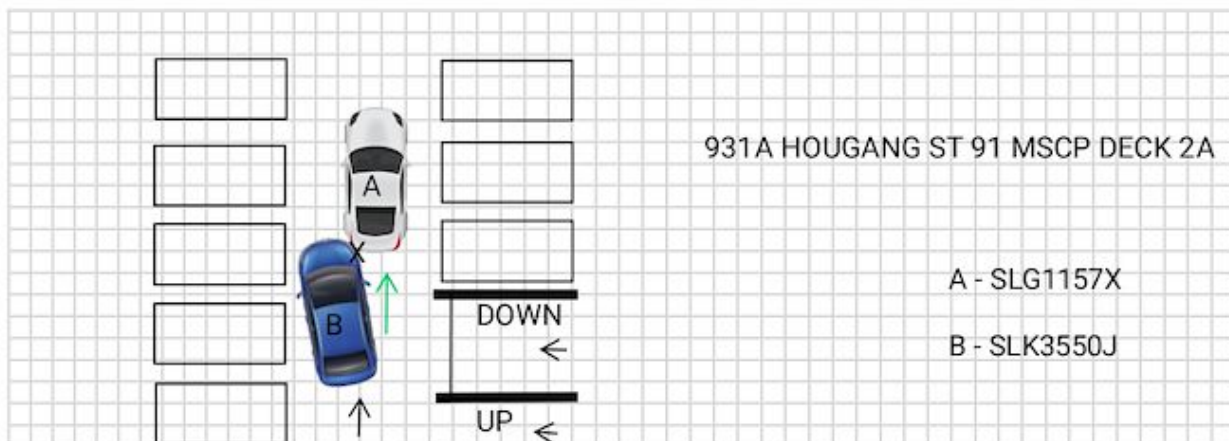
