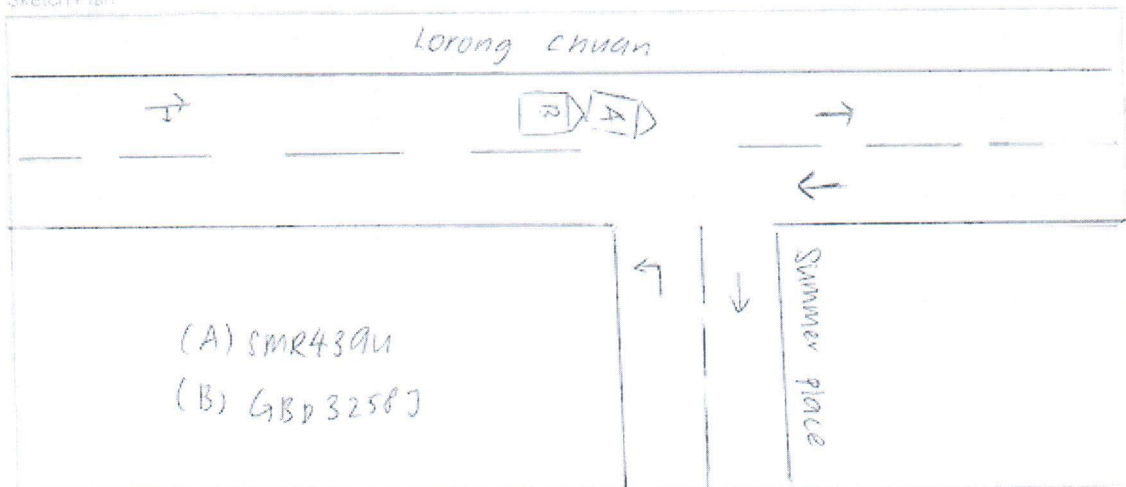


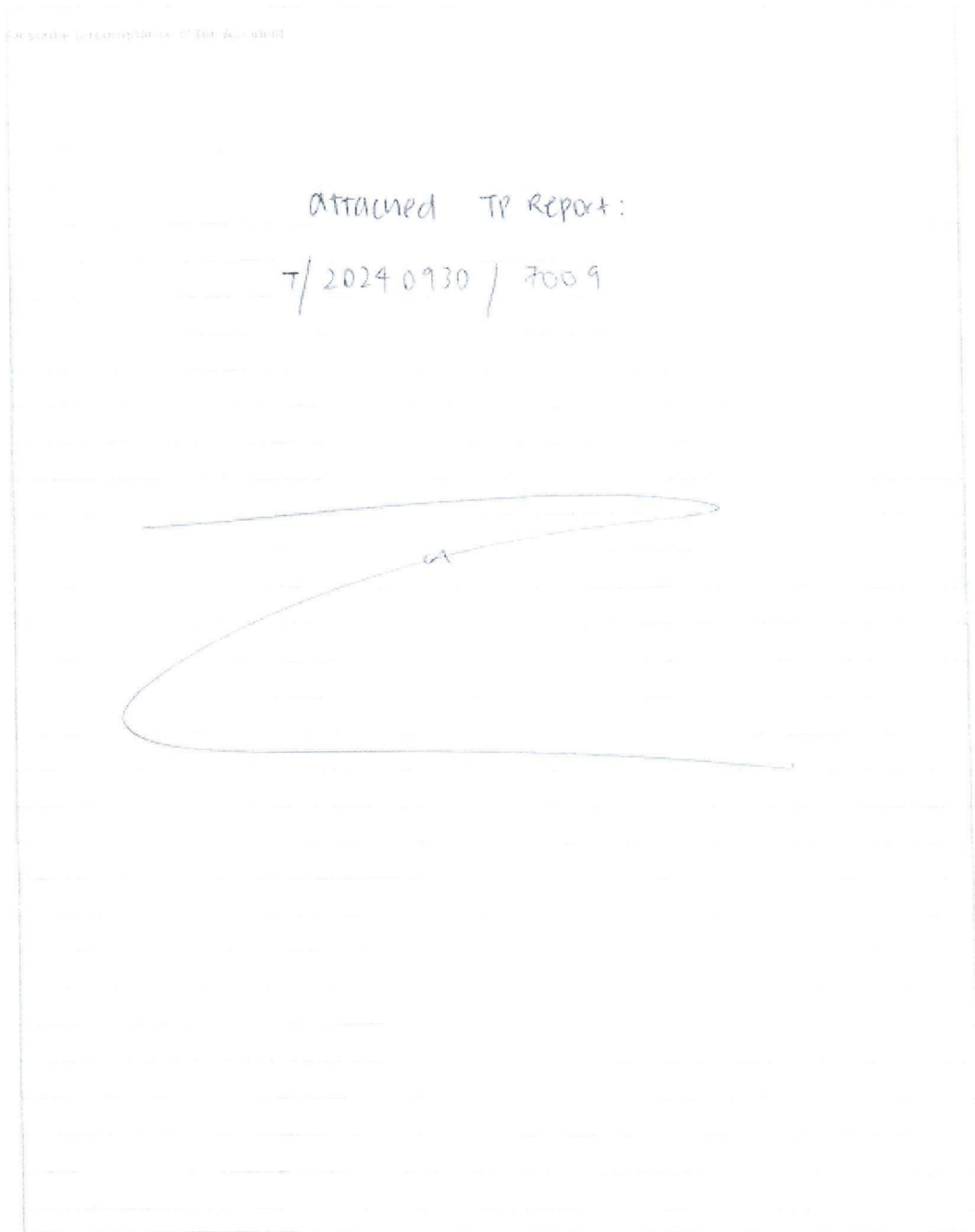

Sketch Plan



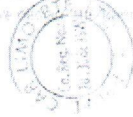
