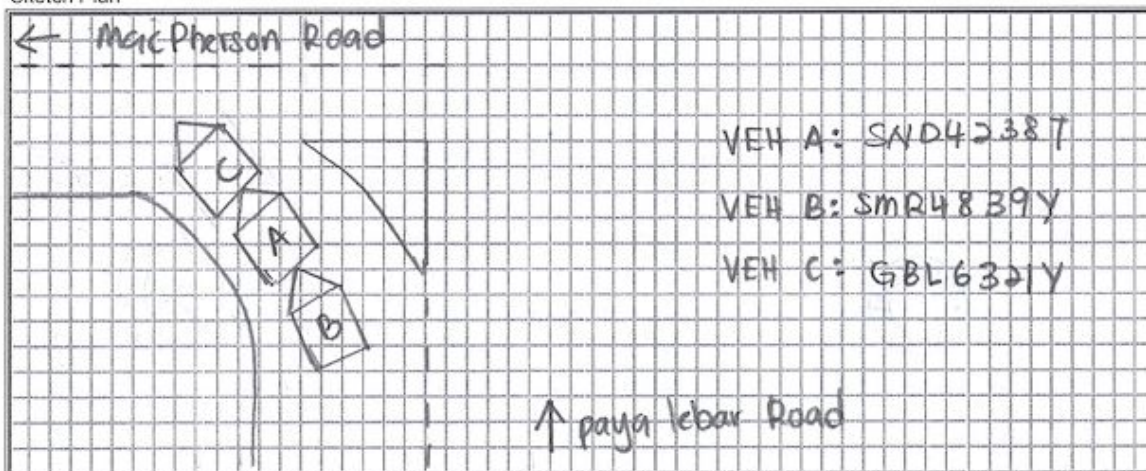

Brief Details.

I, white car SND4238T, was driving along Paya Lebar Road, turning to filtering lane to turn left to Macpherson road (Opposite Grantral Mall). In front of me was a grey van, GBL6321Y, also turning left towards Macpherson road, came to a stop as there were moving cars on the main road. I slowed down and came to a stop behind the van. A red car, SMR4839Y, suddenly collided into my car and hit my rear twice. My car then surged forward and hit the rear of the grey van. Subsequently, all 3 vehicles drivers came down to take photos of the accident and exchanged particulars.

I felt pain on my right collarbone and numbness on my right body and arm. My head was also giddy and I called the police for ambulance assistance. The ambulance and police later came, with the paramedics checking on my condition and the police asking me about the accident. My right body numbness and giddiness slowly cleared up after a while. I informed the paramedics of my intention to head home to rest first and the police advised me on driving the car to the nearest carpark for traffic safety and rest.

I drove back home at about 2.45pm after some rest as my home is quite near (Toa Payoh).

In the evening, I went to see a doctor and was given 3 days medical leave(30 SEP 2024 - 02 OCT 2024) as i still feel sore and slight pain on my right collarbone and neck and lower back.
