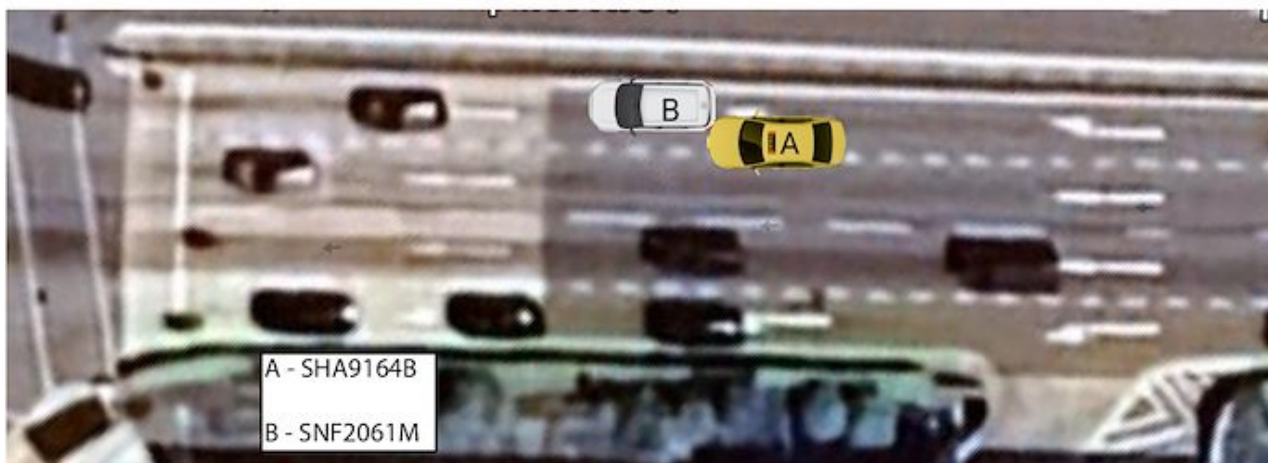

01/10/2024 – 23:00HRS




