CIRCUMSTANCES OF ACCIDENT

On 14th June 2024, at approximately 1530hrs, I was driving my vehicle (SJU3296P) along the PIE towards Tuas near Adam Road. Suddenly, the vehicle in front of me came to an abrupt stop. I managed to stop my vehicle in time to avoid colliding with the vehicle ahead.

Shortly after stopping, I felt an impact from the rear of my vehicle, followed by a second impact. These two impacts pushed my vehicle forward, causing it to collide with the vehicle in front of me. Unfortunately, I did not get the licence plate number of the vehicle in front.

- I exited my vehicle to assess the situation.
- The driver of the vehicle in front, which my vehicle collided with, also exited and inspected his car.
- The driver of the front vehicle indicated that the damage to his car was not serious and decided to leave the scene without further action.
- I observed that Vehicle B (SNH520H) had collided with the rear of my vehicle, and Vehicle C (YQ1373G) was the last vehicle in the sequence.
- No injuries were reported by any of the drivers or passengers at the scene.
- We documented the scene by taking several photographs of the vehicles and their positions.
- After documenting the scene, all parties left the area.
