- 4) BY THE TIME WE WENT OUT OF THE HOUSE, THE CAR HAD ROLLED DOWN THE ROAD, MOUNTED THE KERB OPPOSITE HOUSE NO. 43 NAMLY DRIVE, AND STOPPED.

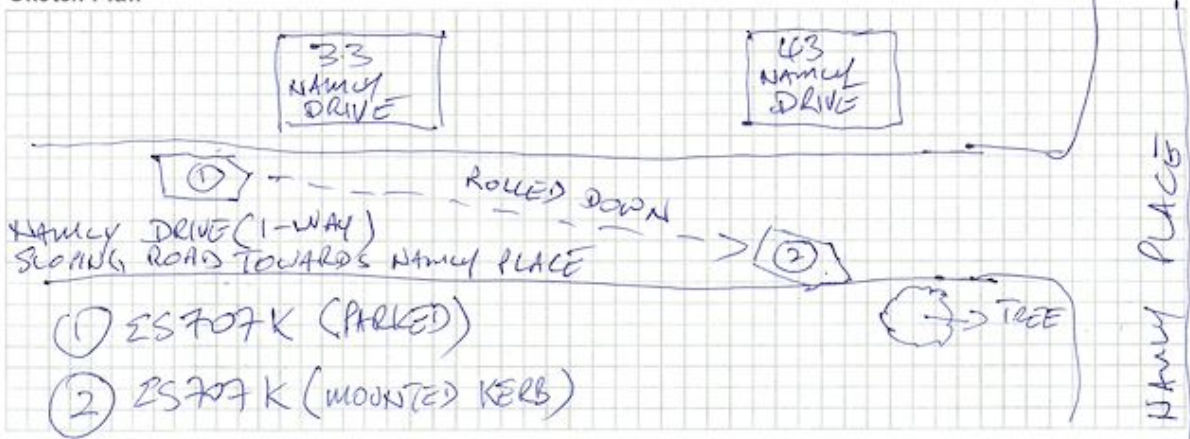

on

① On 8<sup>th</sup> October 2024 at about 12pm, I parked outside 33 Namby Drive, to visit my sister. It was a sloping road.

② At about 12.30pm, my sister's maid alerted us that she saw the car rolling down the road towards Namby Place.

③ We were shocked because the car's handbrake was engaged and gear was in Parked (P) position.

④ By the time we went out of the house, the car had rolled down the road, mounted the Kerb opposite house no. 43 Namby Drive, and stopped.


⑤ Nobody was injured. The car's doors were all still locked.
