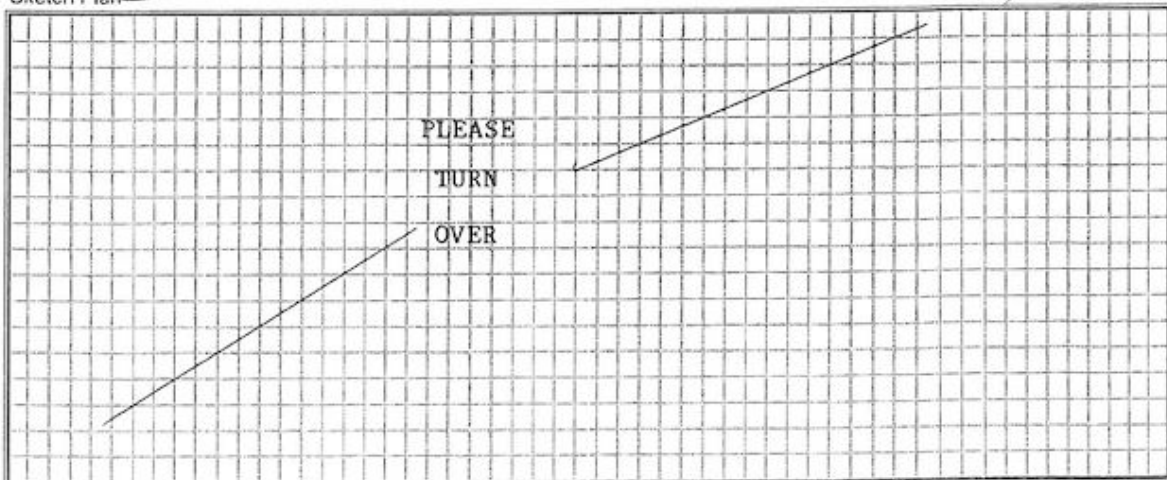

Sketch Plan




