HOWEVER, THE LORRY BEHIND ME (GBG897T) , DRIVEN BY BABU WAS TOO CLOSE BEHIND AND HIT MY CAR REAR PORTION. THE IMPACT WAS SO HARD THAT CAUSED MY HEAD TO KNOCKED FORWARD AND BACK AGAINST THE HEADREST. MY CAR BOTH HEADREST WAS ACTIVATED. THE VAN IN FRONT OF ME DROVE OFF IMMEDIATELY.
