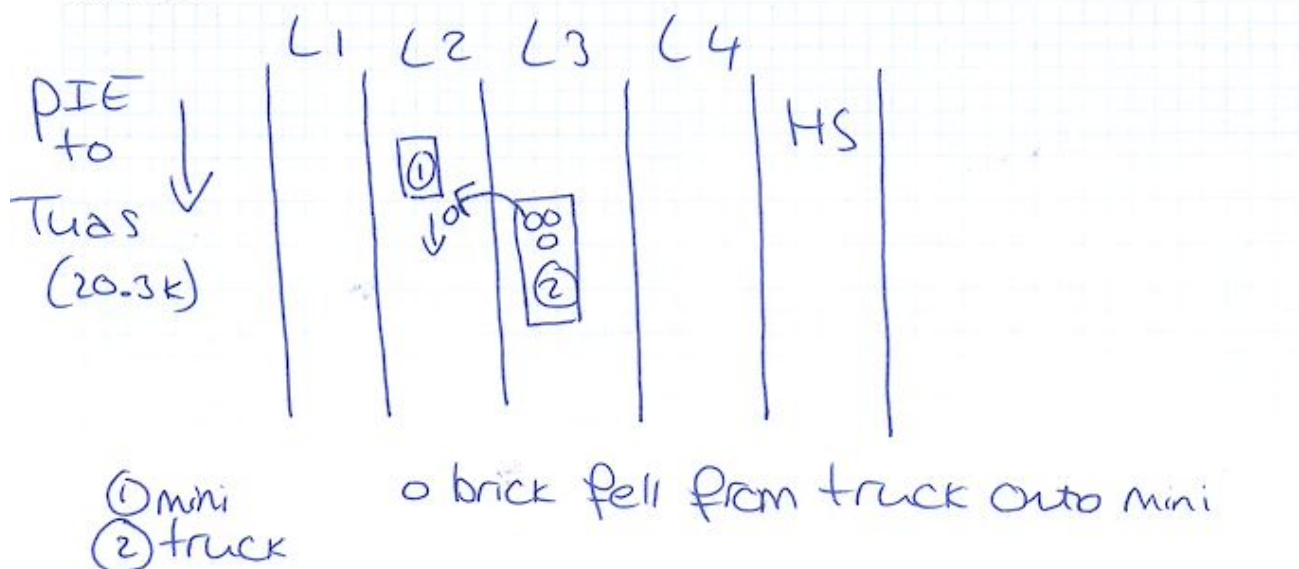

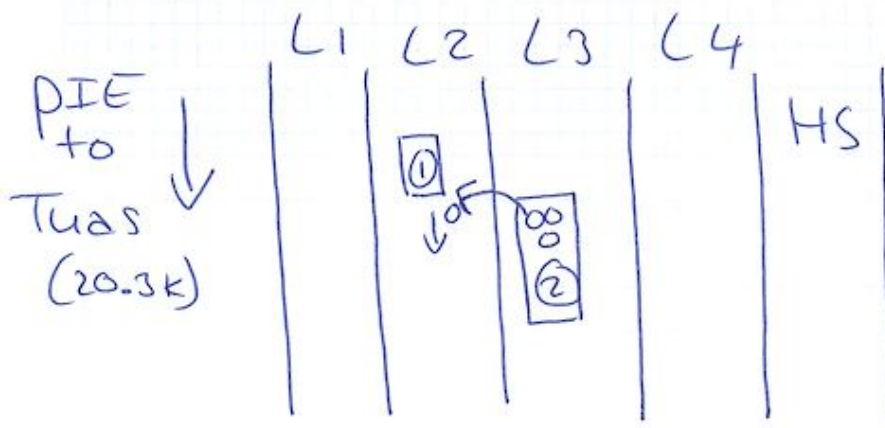

Brief Details.

On 05/06/24 at around 0945hrs, I was driving along the second lane from the middle on the PIE toward Tuas. In front of me was a truck driving on the third lane from the middle. We were both driving around 40-50kph. When we approached the Adam Road exit, a brick fell out from the rear of the truck onto my bonnet and windshield. The brick caused visible damage to the windshield, but did not break it completely. I directed the driver of the truck to the road shoulder where we stopped. The driver of the truck was compliant. Around 15 minutes after we stopped, traffic police travelling along the road saw us on the road shoulder and attended. They made sure I received the particulars and driving license of the truck driver and instructed me to go to Bukit Timah NPC to file a police report. The exact location of the accident they gave me was PIE toward Tuas, 20.3km after Adam Road. There were no passengers in either vehicle and no injuries.

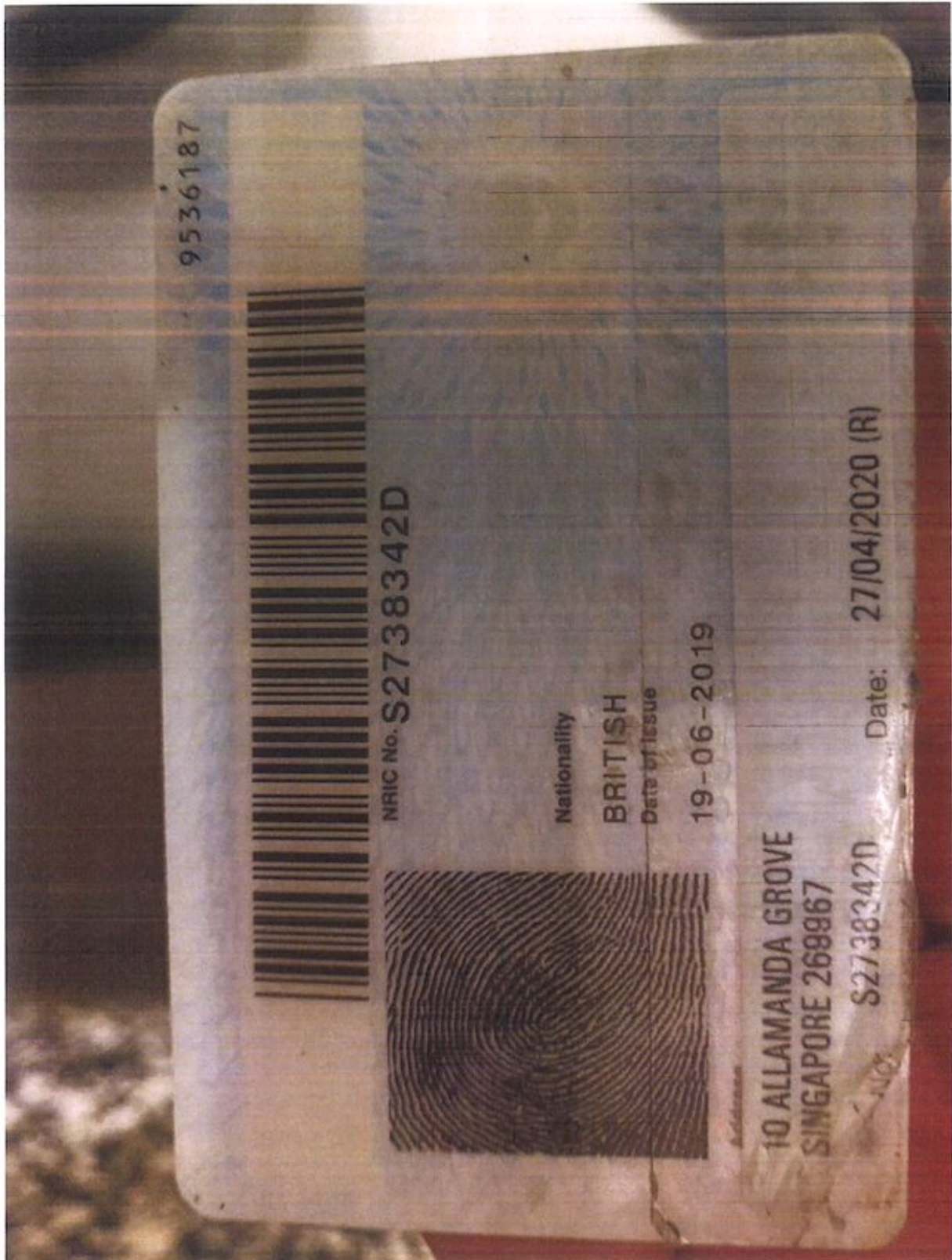
