

On 12th Oct 2024, I was driving on the outer lane on PIE travelling in the direction of Jurong. At 13:52, when my vehicle SKX 7481S was near Toa Payoh I reduced my speed slowly to around 50 km/h from 80 km/h earlier as the traffic in front was getting heavy. Suddenly, I heard a loud bang from behind and my car jerked forward. Realizing that a vehicle has collided into the rear end of my car, I applied brake to bring my car to a complete stop. Thankfully, I maintained a safety distance from the cars in front so my vehicle did not collide with those in front. After which, I came out of my vehicle to check if someone has been injured. Mr. Ho gave me the thumb up sign after I gestured to him with a thumb up. He has a male passenger sitting at the back which is also not injured as far as I can see. I took a video of the conditions of the cars after the collision and a photo of Mr. Ho's IC. My car's rear bumper has fell off and the right side of the rear end was dented. Since no one was injured, I exchanged identification information with Mr. Ho. He asked if I would claim insurance against him. I told him I will report the incident and let my insurance company handle any claim. I called the UOI emergency Assist hotline at 14:36. According to Shelia who answer the call, as the report centres were closed by then, I could send in my car to the report centre on Monday. I verbally informed my t of my accident with my insurer UOI about the accident via the hotline.


