We have visually inspected the vehicle and would like to inform you that we have come to a conclusion that this vehicle is beyond economical repair.

The accident has caused intensive damages on the frontal, undercarriage, whole rear portion and Rear LH Fender of the vehicle which including unconfirmed damages. The damages incurred onto the frontier area, undercarriage, airbag, rear area, spare wheel housing, rear LH fender, rear end panel which estimated to be S\$76,562 for parts.

We also estimated labour cost to be S\$45,274 before any supplementary. Kindly be informed that there will be possible additional damages not visible during inspection.
