LETTER OF AUTHORISATION

1. I/We **CITYLINE GLOBAL PTE LTD** (NRIC No./Company Registration No. **NRIC**) am/are the owner(s) of Vehicle No. **PD9281K** which was involved in an accident with Vehicle No(s). _____ on **17-Oct-2024, 19:00:00** at/along **TAMPINES HEAVY VEHICLE CAR PARK AVE 9**.
2. I/We hereby appoint you as my/our agent to liaise with Third Party and/or its insurers to claim for the damages suffered by me/us, including and not limited to Cost of repairs, loss of use, rental cost, survey fees, medical and hospital bills, special damages, any expenses incurred. I/We hereby authorize you to undertake the necessary repairs to bring the Vehicle back to its pre-accident condition.
3. I/We hereby authorize you to claim against the *Third Party (TP) and/or against my insurer for Own Damaged (OD) or Total loss.
4. I/We authorize you to appoint surveyors to inspect the Vehicle and to pay the Survey fee on my/our behalf prior to carrying out the repairs.
5. I/We entrust you to carry out the repairs diligently and leave it entirely to your discretion in accepting or rejecting any offer of settlement.
6. I/We hereby authorize you to sign Third Party / Our Insurer's Discharge Voucher on our behalf if Discharge Voucher is required by the insurers. We hereby authorize you to receive the settlement sum from the insurers directly into your bank account.
7. I/We hereby authorize you to appoint solicitors on my/our behalf if necessary. I/We authorize you to give instructions to the appointed solicitors to act on my/our behalf to recover damages arising out of the accident from the parties concerned. I/We acknowledge that all instructions given to them by you will therefore be as good as if they were given by me/us. We hereby authorize the solicitors to release all monies recovered and received by them in connection with this claim directly to you and to be made in the name of **SC Auto Industries (S) Pte Ltd** after deducting their fees.
8. I/We authorize you to deduct the sum(s) of money recovered for the costs of repair to meet your repair bill, the survey fees, your handling fees, administrative charges and any other expenses incurred on my/our behalf. Any sum(s) of money recovered for the loss of use will be returned to me/us after deducting handling fees. We understand that all monies due to me/us shall only be released to me/us after we have signed your discharge vouchers for the case.
9. I/We understand and appreciate that my/our claim may be unsuccessful or only partially successful. In such an event, I/We shall pay you the repair costs or any shortfall on receipt of your invoice. I/We shall also reimburse you for all other expenses incurred by you on my/our behalf including your administrative charges.
10. I/We shall on your request furnish you with all relevant documents, evidence, and information promptly to enable you to process the claim expeditiously. I/We shall promptly arrange for our driver involved in the accident for interview by you or the appointed solicitor. I/We or our driver also agree to attend court and/or be a witness if necessary. You shall have the right to discharge yourselves as my/our agent should I/We fail to co-operate with you or furnish you with the relevant documents/information by giving me/us written notice to that effect. In such an event, I/We shall pay the repair costs immediately on receipt of your invoice and reimburse you all other expenses incurred by you on my/our behalf including your administrative charges.
11. I/We reserve the right to terminate your appointment as our agent at any time so long as you have not received any offer of settlement from insurers. In such an event, I/We shall pay the repair costs immediately on receipt of your invoice and reimburse you all other expenses incurred by you on my/our behalf including your administrative charges.
12. I/We acknowledge your right to have a lien over all documents and money held by you until all monies owed by me/us to you (where applicable) has been fully settled.
13. I/We hereby agree to pay you the following handling fee:
 - (a) 20% of the total amount claimed for loss of use (after deducting the legal and survey fees) where Court attendance is not required; or
 - (b) 25% of the total amount claimed for loss of use (after deducting the legal and survey fees) where Court attendance is required.
 - (c) 15% of the total amount claimed for Total Loss case, subject to a minimum fee of S\$1500

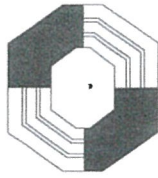
