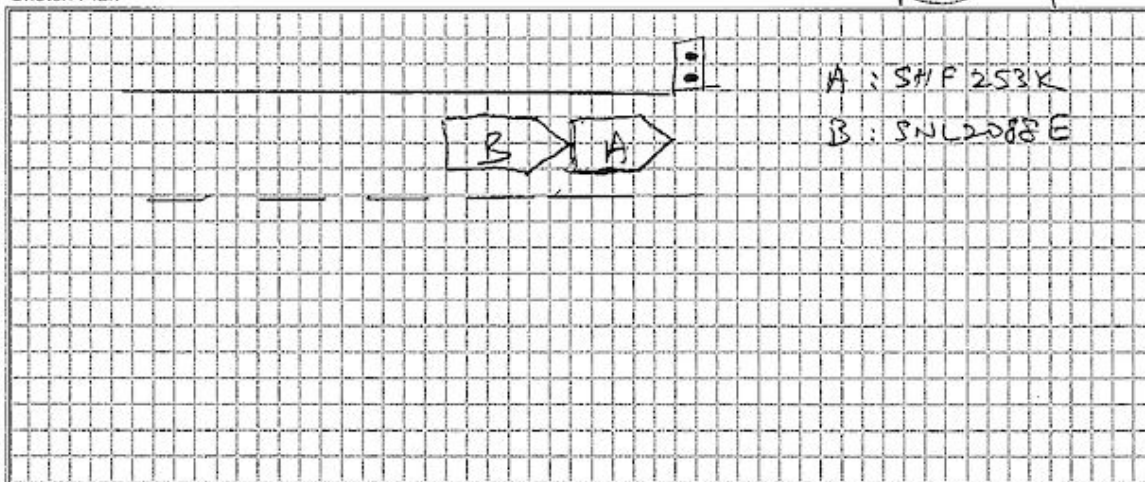

<p>It was raining on the evening of 3rd June, 6pm after a slight drizzle, when coming to traffic light, I slow rolled into the car in front of me. The car plate is SHF253K. It was a slight touch. We both came out of the car to review the damage. As the bump was so slight, there was no damage to my car and I could hardly see anything caused by my bump. In fact his car bumper was in such bad condition, the other scratches were more serious.</p> <p>We originally offered him \$100 out of good will but he rejected. When he decided he wanted the \$100, I decided not to offer as there was really no damage, and challenge him to sought insurance claim. I chose to do so as I do not expect insurance to entertain this claim. His claim is merely to subsidise the replacement of his whole damaged bumper.</p>
