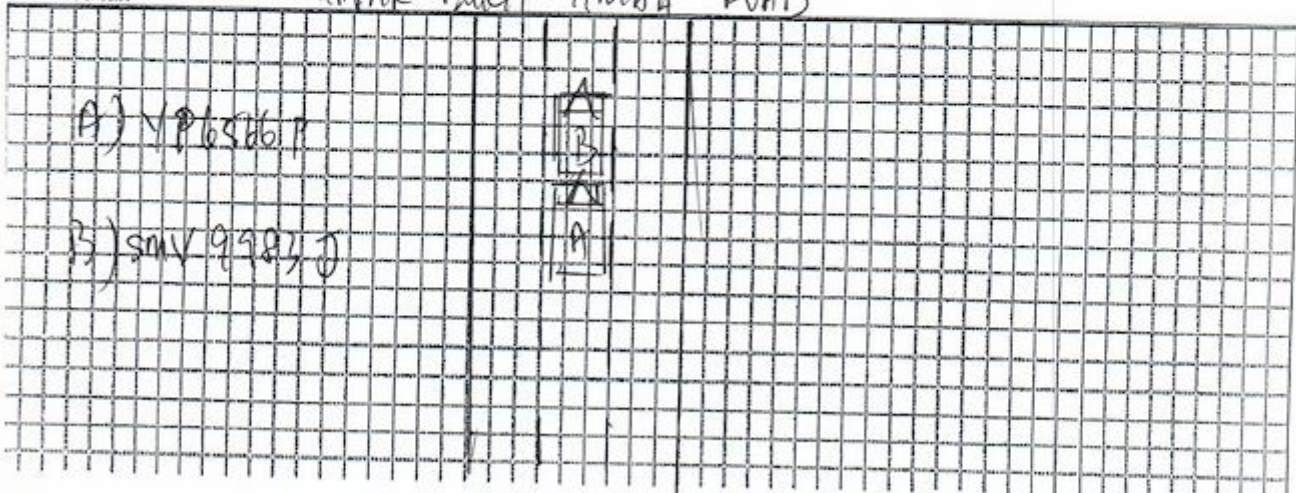

Describe Circumstance of the Accident


While reaching the traffic light it turns to red before the Car.
