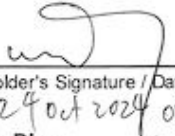

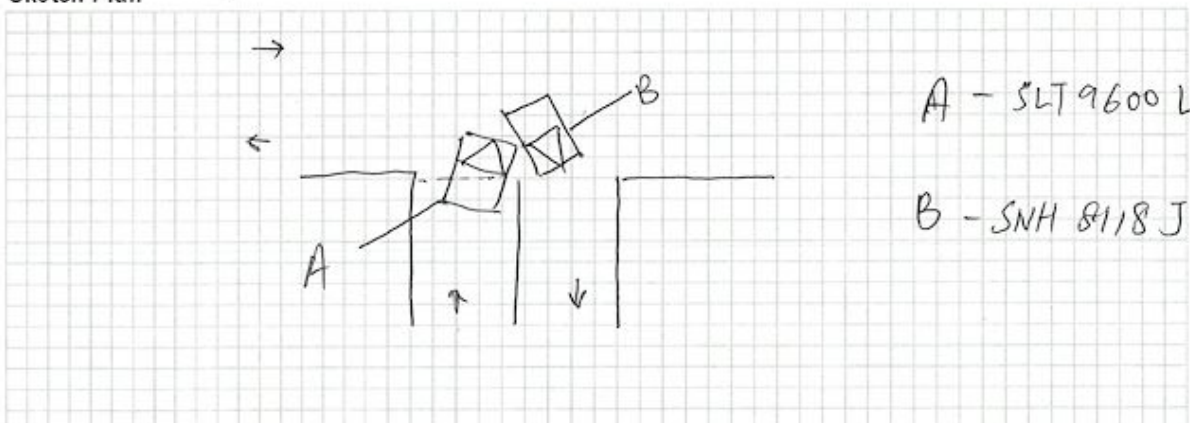

Describe Circumstances of the Accident

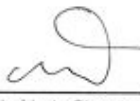

I was waiting to turn right, noting that the 3rd party vehicle SNH 8118J was moving on Kensington Park Road. I noted that SNH 8118J was turning right, I started to turn right into Kensington Park Road.

Both cars collided. My front right part of the car was damaged at about 7.58am
