





Report No. G/20240729/7040

On 28/07/2024 at about 2115hrs I parked my motorbike Yamaha Xmax dark brown bearing the plate FBN5973L at Shell Simpang Bedok along with other motorbikes. I had parked opposite pump 10.

I then proceeded to have my meal at Simpang Bedok and don't have view of my bike. after my meal i came back and found my motorbike not in the position that i left. when I left it was on my mainstand instead when I came back it was on my side stand.

I inspect my bike and found multi scratches and cracks on the right side of my bike from front to back. I asked the staff at Shell, Aqmal who was working that night if he witness anything but to no avail. He informed me that he will whatsapp me after viewing CCTV.

Later in the evening I received a Whatsapp footage from Aqmal. A minibus in white could be seen in the footage reversing into my bike. The subject then picked up my bike and left the scene. Subj did not leave any note or exchange contact details.

I will be on overseas from 29/07/2024 - 02/07/2024 but will be contactable via Whatsapp. I also have footages and images of the incident. Staff Aqmal informed if require a clearer footage able to ask him but require IO. Aqmal also provided a plate number of the minibus from the footage PC363Y. Pump attendant uncle Lim was at scene and witness when the incident happened.


