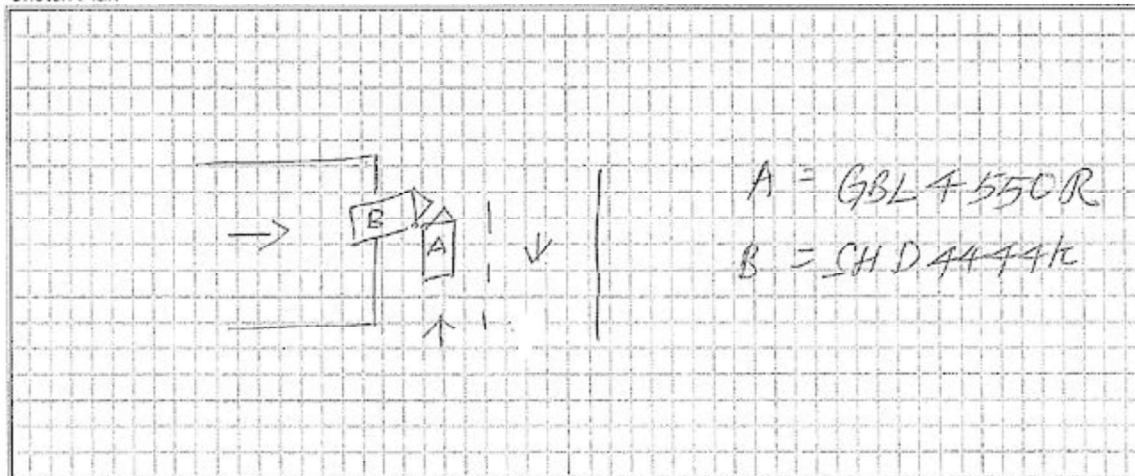

Sketch Plan









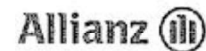
