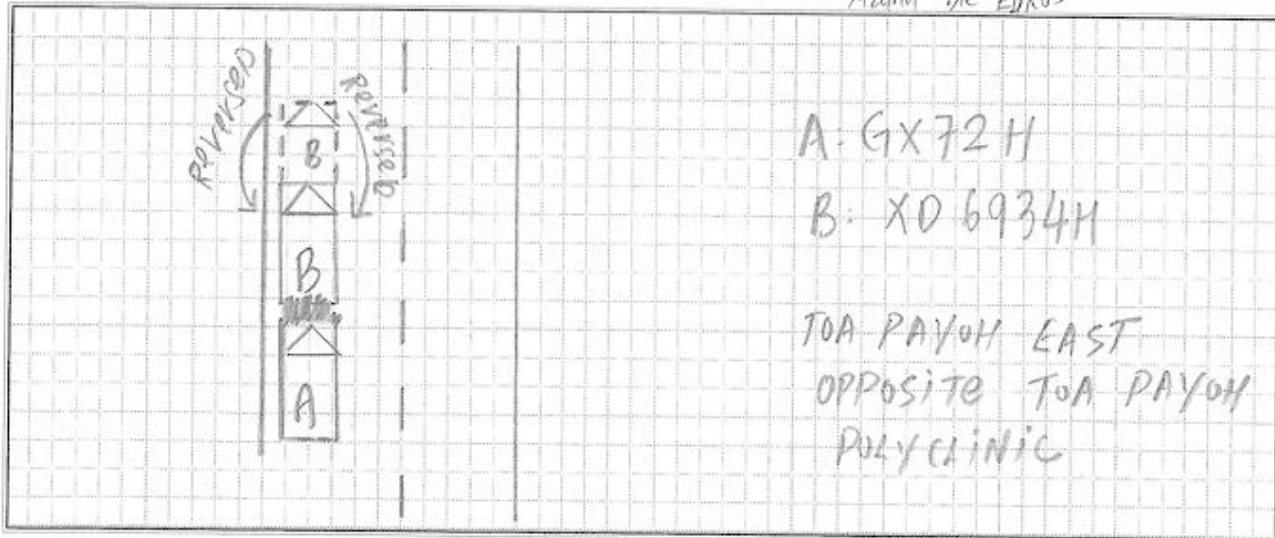

Describe Circumstance of the Accident

ON 29TH OCTOBER 2024 AT ABOUT 1150HRS, MY VEHICLE A (GX72H) WAS PARKED ALONG TOA PAYOH EAST, OPPOSITE TOA PAYOH CLINIC. AFTER 10 MINUTES WHEN I CAME BACK I SAW MY VEHICLE A (GX72H) FRONT PORTION WAS BADLY DAMAGED, CAUSED BY VEHICLE B (XD6934K). MY FRONT WINDSCREEN CRACKED BADLY, MY WIPER BROKEN AND MY FRONT PART DENTED, MY RIGHT HAND SIDE MIRROR BROKEN.

DRIVER OF VEHICLE B (XD6934K) HAD REVERSED HIS VEHICLE UNTIL HIS REAR PORTION OF HIS VEHICLE B (XD6934K) HAS COLLIDED WITH MY FRONT PORTION OF MY VEHICLE A (GX72H).
