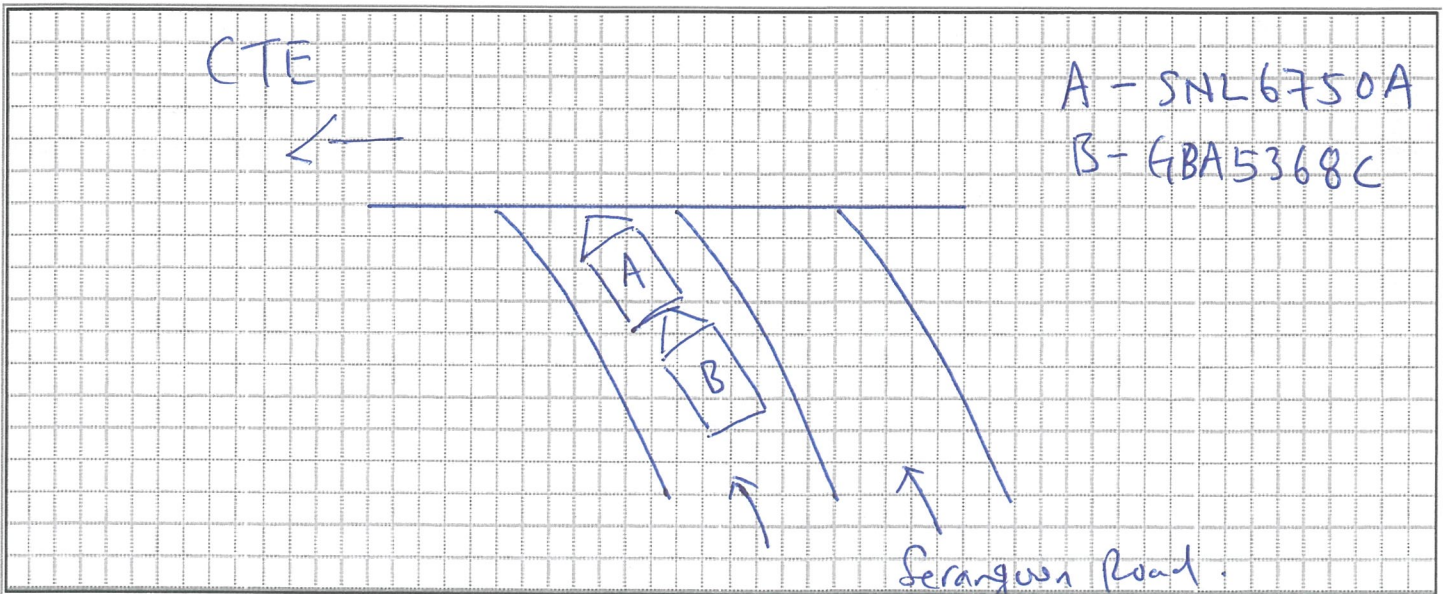

The driver of the lorry deny the hit and did not provide any contact information.


